 - The **fee** per arts and crafts vendor space is \$50. We charge this small fee to ensure we can continue to host this special event year after year.
 - Space is reserved once payment and application are received and a confirmation email has been sent to the vendor. Space is limited so sign up early. **Deadline to sign up is June 20th.**
 - The HarborFest Committee reserves the right to reject vendors due to space limitations and duplicate vendor offerings.

- This is a rain or shine event. No refunds will be given after June 20th.
- **Arts & crafts vendors may begin setup between 7:00 a.m. – 10:30 a.m.** Vehicles must be moved by 10:30 a.m. Parking instructions will be sent before the event.
- Teardown will begin no earlier than 3:00 p.m. Vendors will not be allowed to leave the event before this time.
- **There is limited power available.** If you would like to request power, please indicate this on your application. We will approve power requests on a case by case basis, pending availability.
- Vendors must provide tables, chairs, and tent.
- Vendors are responsible for cleaning up their area or they will be charged an additional \$25.00 clean up fee.
- Wells HarborFest reserves the right to refuse or remove any vendor who acts inappropriately or unprofessionally.
