



WESTON DTC SEARCH COMMITTEE NEWS & UPDATES

Our Search process includes announcements at the DTC meetings, in our newsletter, Weston Today, and outreach in the community. We meet on the 1st Wednesday of each month to review CVs and conduct interviews of any interested candidates. The Committee then puts forward a candidate for endorsement by the DTC at their meetings held on the 2nd Wednesday of each month (7:15PM @ Town Hall). Endorsed candidates are then introduced to the Board of Selectmen who conduct their own interviews and vote on final appointments.

OPENINGS

Weston Beautification Committee

Purpose: The committee is dedicated to enhancing the visual appeal and environmental sustainability of Weston's public spaces. This committee provides guidance on aesthetic decisions related to town properties and leads initiatives to improve the natural environment through sustainable landscaping and native plantings. The committee plays an integral role in projects such as the Town Green revitalization, seasonal decorations, and the maintenance of gardens and public areas around town. Key responsibilities include:

- **Advising on Town Aesthetic Choices:** The committee offers input on both interior and exterior design elements for town properties, with a focus on maintaining Weston's charm and enhancing the community's natural beauty.
- **Sustainable Landscaping and Environmental Stewardship:** The committee emphasizes the use of native plants and sustainable practices, ensuring that Weston's landscapes support biodiversity, pollinators, and eco-friendly practices
- **Community Beautification Projects:** The Beautification Committee oversees various projects such as the Weston Town Green revitalization, which includes native garden installations, creating spaces for public gatherings, and preserving Weston's historic and natural features
- **Seasonal Planting and Maintenance:** The committee is responsible for maintaining and planting seasonal displays at key locations like Town Hall, the Library, and the Senior Center, often collaborating with local organizations for funding and execution
- **Public Engagement and Education:** The committee works to engage the community in understanding the value of native plants and sustainable landscaping, often providing educational materials and hosting events that raise awareness

Building Board of Appeals

Purpose: The Weston Building Board of Appeals is responsible for hearing appeals related to decisions made by the Town's Building Inspector. When individuals or entities believe a decision or interpretation of the building code is incorrect or unfair, they may bring their case before this board for review. The board ensures that building regulations are fairly enforced while considering reasonable alternatives and variances where appropriate. Key responsibilities include:

- **Review of Appeals:** The primary function of the Building Board of Appeals is to hear and decide on appeals against decisions or interpretations made by the Building Inspector.
- **Interpretation of Building Codes:** The board interprets building codes and regulations to ensure compliance while maintaining flexibility for unique cases that require special consideration

Advisory Role: The board may advise on amendments or updates to building codes based on their findings from hearing appeals

VETERANS AFFAIRS COMMITTEE (Appointed)

Before moving to Weston and starting his law firm, Jim worked as a corporate and in-house attorney for several major law firms and multinational corporations. His experience includes representing early-stage investors and their portfolio companies from initial funding rounds through the corporate lifecycle, often acting as an outsourced General Counsel. Additionally, he represented the court-appointed trustee under the Securities Investor Protection Act for the liquidation of Bernard L. Madoff Investment Securities LLC, coordinating hundreds of legal proceedings and avoidance actions all over the world. He has counseled owners and developers of residential and commercial real estate in addition to debtors, creditors, and acquirers of distressed assets in numerous complex bankruptcies and restructurings.

Before his legal career, Jim served as a Naval Officer and military intelligence analyst. He was deployed to the Middle East in support of UN trade sanctions and to South America as the Anti-Terrorism and Gunnery Officer aboard a guided missile frigate, where he participated in one of the U.S. Navy's most successful counter-narcotics operations. He also taught graduate students as a Visiting Professor in one of Mozambique's first MBA programs, focusing on Finance, Entrepreneurship, and Business Planning. Jim is a graduate of the United States Naval Academy, where he captained the golf team, and holds a law degree and an MBA from Georgetown University. While studying at Georgetown, he worked as an analyst at the Office of Naval Intelligence and interned at the U.S. Department of Justice. Additionally, he has volunteered as an instructor at The First Tee and the Bridge Golf Learning Center of Harlem, organizations that use golf to teach important life lessons to youth in underserved communities.

Lisa Luft moved to Weston with her husband Harvey and their three children over 30 years ago.
