NOTICE TO INDUSTRY_COVID-19 NATIONAL LOCKDOWN

The BIBC notes with great concern, the daily increase in COVID-19 infection rates in South Africa. The Construction sector as well as the BIBC operation are NOT designated essential services. This means that the BIBC will be closed for the duration of the lockdown that extends from midnight on Thursday 26th March until midnight on Thursday 16th April 2020.

There have been a number of proposals and suggestions coming from the industry and we have considered these inputs in order to formulate this formal response to the National Lock-down.

HOLIDAY FUND AND BONUS BENEFIT ADVANCE

The BIBC will pay out all Holiday Fund and Bonus benefits processed for the current benefit year i.e. from 1 November 2019 to 26th March 2020 actual amounts received. This advance will be processed by 31st March 2020. This payout will only be available to the employees of the compliant employers and will be based upon the amounts available in respect of the current benefit year.

We will be using the current bank details on file so do not visit the BIBC offices for payment as we will be closed.

Please note that this is an advance. The amount paid out will be deducted in the normal year-end payout.

BENEFIT PURCHASES

Due to the fact that no employees will be working, no benefits and council levies will be purchased during the period of Lock-down. This period includes any extensions to the initial period communicated by President Cyril Ramaphosa.

In terms of the main Collective Agreement, the holiday period for the 2020 year-end has already been concluded. However, parties to the main Collective Agreement will continue discussions to evaluate the implications of the Lock-down. The outcomes of negotiations in this regard, will then be duly communicated.
