RULES OF THE REGIONAL HEALTH & SAFETY COMPETITION 2021

Members must enter all their current projects, as well as their plant yards, where applicable, to qualify for participation in the competition.

The rules are as stated below:

1. The closing date for entries will be the **26th March 2021**.
2. The entry form must be completed, and all information provided.
3. We require the name of the person responsible for safety as well as a contact number.
4. Only sites that have 50% of the applicable items on the audit form in place are eligible for entry into the competition.
(Sites that might not qualify immediately but will be ready before the end of the competition may be entered, but this must be clearly marked on the entry form)
5. The sites will be audited over a period of 4 months - March 2021 to end June 2021.
6. If it is found during an audit that basic requirements are not in place, the audit will be abandoned.
7. A copy of the MBSA Audit form is available to everyone and this can be used as a check list, as well as a guide to the correct filing of documents.
8. **A copy of the new plant yard, manufacturers and allied trades will be available.**
9. The following items must be available before an audit will take place:
 - The current DIFR of the site as determined by the international formula supplied with the audit form.
 - **Please note that any restricted, light duty cases are regarded as a lost time/disabling injury for the purposes of the MBSA audit system and the calculation of the DIFR for the site.**
 - The proof of registration for COIDA, i.e. letter of good standing.
 - An up to date risk assessment specific to the site.
 - Site safety plan.
 - ***Man-hours for the sub-contractors and the principal contractor for the duration of the site. This must be available at the start of the audit.***

Important to note:

- All the sites entered should score at least 80% for the MBSA audit prior to entry.
- These audits take time to be done properly and fairly, and it is therefore very important that the paperwork on sites be organised in such a way that documents are readily available to the audit team.
- The MBA safety team is readily available to assist members with site pre-audits.
- **We encourage all our members to use the MBSA Audit form as a guideline.**
