
Counter/Reception Screens: Height : 900mm; Width options : 590mm, 750mm, 900mm, 1200mm, 1500mm

Only for use indoors and in wind free areas



Assembly: Some Goods will require assembly upon delivery. The Sneeze Protective Screen is an easy 3 step assemble with no training needed. We cannot be held liable for the incorrect assembly of any Goods by you or any third party.
