

## PACP Column: September 2024

An abundance of shovel-ready projects and job creation signals a stronger economy. That's why the PA Chamber team successfully advocated to realize our goal of permitting reform in the 2024-25 state budget signed earlier this summer.

Notably, the new Streamlining Permits for Economic Expansion and Development (SPEED) Program improves state permitting processes for several key PA Department of Environmental Protection permits. These reforms will reduce delays in development and business expansion projects – a priority for employers, as delays had long led to projects being shelved, canceled, or lost to other states. The improvements include:

- Allowing employers to work with third-party professionals to facilitate permit application reviews.
- Establishing timeframes with clear accountability measures for permit responses.
- Implementing measures for easier and more transparent tracking of permit applications.

The SPEED program will help streamline the permitting process and make Pennsylvania more competitive. It will also help ensure that newly authorized funding for the PA Strategic Investments to Enhance Sites (SITES) Program is efficiently deployed to successfully prepare business sites for development.

Last year, the PA Chamber led a [coalition](#) of 68 business associations and local chambers in calling on Gov. Shapiro and the legislature to advance permitting reform. And, this year, the PA Chamber joined forces with the state building trades in an [op-ed](#) calling for permitting reform. The permitting reform package signed into law this year includes many of the reforms advocated for by the PA Chamber and its partners.

DEP officials will discuss the implementation timeline for the SPEED program and other energy-related policy items at our upcoming [DEP Quarterly](#) meeting on Wednesday, September 11.
