## **SB38/HB16 CAMPAIGNS & LOBBYING: Fundraising for general assembly members during recess in even-numbered years.**

*Sponsors:* Sen. Southerland, Steve , Rep. Goins, Tilman  
*Summary:* Authorizes members of the general assembly and political campaign committees to fundraise during a recess in even-numbered years if the general assembly recesses before May 15 for a period of not less than 10 calendar days, Sundays excepted.

## **SB47/HB57 GOVERNMENT ORGANIZATION: Rearranging the political primary ballot for elections.**

*Sponsors:* Sen. Massey, Becky , Rep. Zachary, Jason  
*Summary:* Reorders the presidential primary ballots to increase the number of vertical columns for each respective party's primary election on the ballot from two to three and allow for candidates for state and municipal offices to immediately follow the names of the presidential candidates.  
*Amendment Summary:* House Local Government Committee amendment 1, Senate amendment 1 (002511) adds language to the original bill to require the names of candidates for county offices to appear between the names of candidates for state and municipal offices on Presidential Preference Primary ballots.

## **SB135/HB98 CAMPAIGNS & LOBBYING: Nonpartisan elections for state trial court judges in Shelby and Davidson counties.**

*Sponsors:* Sen. Dickerson, Steven , Rep. Lamberth, William  
*Summary:* Requires Shelby and Davidson counties to conduct nonpartisan elections for all state trial court judgeships, county judicial offices, and judicial clerk offices.  
*Amendment Summary:* House Local Government Subcommittee amendment 1 (003562) removes the last sentence of Section 1, which states that the incumbent officeholder shall be listed first on the election ballot provided that the incumbent has qualified for reelection.

## **SB227 CAMPAIGNS & LOBBYING: Precinct or supplemental registration publication requirements for county commissions.**

*Sponsors:* Sen. Beavers, Mae ,  
*Summary:* Removes publication requirements for precinct or supplemental registrations for county commissions.  
*Fiscal Note:* (Dated February 15, 2017) Decrease Local Expenditures - \$400

## **SB228/HB264 CAMPAIGNS & LOBBYING: Appointment of election officials by county election commissions.**

*Sponsors:* Sen. Beavers, Mae , Rep. Lynn, Susan  
*Summary:* Expands the time period, from 10-60 days to 10-90 days, in which the county election commission must appoint election officials before an election. Permits election officials to direct their compensation to a charitable organization, as long as said organization is not religiously or politically affiliated.

## **SB286/HB162 CAMPAIGNS & LOBBYING: Voting by absentee ballot.**

*Sponsors:* Sen. Lundberg, Jon , Rep. Crawford, John  
*Summary:* Allows an absentee ballot to be sent to an address within a county, regardless of whether the voter requesting the absentee ballot possesses a commercial driver license or a valid transportation worker identification credential.

## **SB320/HB1074 GOVERNMENT ORGANIZATION: General assembly legislative software for public use.**

*Sponsors:* Sen. Harris, Lee , Rep. Jones, Sherry  
*Summary:* Authorizes the public to access the same legislative dashboard as the members of the general assembly. Requires the office of legislative information systems to ensure that the information provided on the dashboard does not violate attorney-client privilege

laws.

**SB322/HB1186 GOVERNMENT ORGANIZATION: Voting records of the general assembly.**

*Sponsors:* Sen. Harris, Lee , Rep. Powell, Jason  
*Summary:* Requires that the joint legislative services committee publish the voting records of each member of the general assembly to the official state website. Specifies that a member's voting record includes all bills voted upon in their respective house, as well as the bill number, subject matter of the bill, the member's vote, and the total floor vote. Requires that the member's voting record remain on the state website until the end of the subsequent two year general assembly at the minimum.

**SB327/HB275 GOVERNMENT REGULATION: Disclosure of travel expenses by the General Assembly.**

*Summary:* Requires members of the General Assembly who have their travel expenses paid for by politically interested persons to disclose the amount and source of the reimbursement.

**SB342/HB867 CAMPAIGNS & LOBBYING: Order of candidates on all ballots.**

*Sponsors:* Sen. Niceley, Frank , Rep. Holsclaw, Jr., John  
*Summary:* Requires candidates to be listed in alphabetical order in a presidential election year and the following year and in reverse alphabetical order in a gubernatorial election year and the following year on all ballots. Broadly captioned.

**SB344/HB1300 CAMPAIGNS & LOBBYING: Changes to the nomination process for candidates for United States senator.**

*Sponsors:* Sen. Niceley, Frank , Rep. Lynn, Susan  
*Summary:* Removes the power to nominate a candidate for United States senator from statewide political parties. Requires the house of representatives and senate members of the majority party to nominate a person to run as that party's candidate by joint caucus in an open meeting. Also requires the house of representatives and senate members of the minority party to nominate a person to run as that party's candidate by joint caucus in an open meeting. Prohibits any person nominated at the joint caucus who does not win the nomination as candidate for the majority or minority party from qualifying as an independent or write-in candidate in the general election for United States senator. Allows a recognized minor party to nominate persons for the United States senate by any rules of the party or by primary election.

**SB352/HB181 CAMPAIGNS & LOBBYING: Deletes requirement to publish a newspaper notice of location and time for supplemental voter registration.**

*Summary:* Deletes the requirement that a county election commission publish in a newspaper of general circulation a notice of the time and place of a supplemental voter registration, at least three days before the supplemental voter registration, and with notice that transfers of registration can be conducted at the supplemental voter registration.

**SB377/HB704 CAMPAIGNS & LOBBYING: Investment of campaign funds.**

*Sponsors:* Sen. Overbey, Doug , Rep. McCormick, Gerald  
*Summary:* Requires that all campaign funds be deposited into an FDIC or national credit union administration insured financial institution. Also requires any interest, dividends or income earned by such investment to be reported on the candidate's or political campaign committee's financial disclosure report. Prohibits non-authorized investments. Allows the registry of election finance to impose a civil penalty for a violation of not more than \$10,000 or 115 percent of the amount invested in violation, whichever is greater.

**SB403/HB609 CAMPAIGNS & LOBBYING: Churches and religious organizations exempt from campaign finance disclosures.**

Sponsors: Sen. Gresham, Dolores , Rep. Gant, Ron

Summary: Exempts churches and other religious organizations from campaign finance disclosures when expending funds in favor of or in opposition to single or multiple issue measures related to public or private morality, including, but not limited to, alcohol, drugs, abortion, marriage, or gambling.

**SB422/HB423 CAMPAIGNS & LOBBYING: Allows any registered Tennessee voter to vote absentee for any reason.**

Sponsors: Sen. Yarbro, Jeff , Rep. Clemmons, John

Summary: Permits any registered Tennessee voter to vote absentee for any reason after providing a certification as to the identity of the voter in the application for a ballot. Requires an absentee ballot to be counted for the election in which the ballot is cast. Removes provision that the commission may not recount any paper ballots, including absentee ballots.

**SB512/HB625 CAMPAIGNS & LOBBYING: Political advertisement that implies a candidate is an incumbent.**

Sponsors: Sen. Jackson, Ed , Rep. Shaw, Johnny

Summary: Prohibits a political advertisement from implying a non-incumbent candidate is an incumbent. Requires a political advertisement to include the number or letter of the district, ward, or seat for which the candidate is running, if applicable.

**SB516/HB784 CAMPAIGNS & LOBBYING: Vacancy in the office of US senator.**

Sponsors: Sen. Kelsey, Brian , Rep. Littleton, Mary

Summary: Changes appointing authority for the office of United States senator until a successor can be elected in the next regular November election from the governor to the general assembly. Requires the governor to call the general assembly into a joint special session if the vacancy occurs and the general assembly is not in regular annual session. Requires the successor appointed to be a member of the same political party as the predecessor. Allows the general assembly to nominate candidates to fill the vacancy. Requires nominees to meet the constitutional qualifications to serve as a United States senator. Specifies the general assembly's procedure for voting for the candidates.

**SB517/HB1040 CAMPAIGNS & LOBBYING: Revises provisions governing the use of mobile electronic and communication devices at polling places.**

Sponsors: Sen. Kelsey, Brian , Rep. Camper, Karen

Summary: Allows a county commission or its duly appointed election official to prohibit a voter from using a mobile electronic or communication device at a polling place if the voter is using the device to photograph a ballot, threatening the use of force or violence to compel a person's vote, or intending to disrupt others.

**SB588/HB1182 CAMPAIGNS & LOBBYING: Filing of tax returns by candidate for president of the United States.**

Sponsors: Sen. Yarbro, Jeff , Rep. Powell, Jason

Summary: Prohibits all county election commissions from printing the names of primary or general election candidates for the presidency of the United States who have not filed their tax returns with the secretary of state for the past five years. Requires the secretary of state to notify each candidate that they must file their tax returns for the preceding five years in order to be placed on the primary or general election ballot.

**SB592/HB787 CAMPAIGNS & LOBBYING: Automatic voter registration.**

Sponsors: Sen. Yarbro, Jeff , Rep. Stewart, Mike

Summary: Establishes automatic registration of a person to vote when a person applies for a motor vehicle driver license or photo identification license. Deletes the requirement that the voter registration section of an application must include a box or device to permit an applicant to decline to register to vote. Requires a person to notify the county election commission office if they wish to decline to register to vote within twenty-one days of the commission receiving the application from the motor vehicle office.

*Intro Dates:* Grants the secretary of state the ability to promulgate rules to effectuate automatic registration.

**SB616/HB672 CAMPAIGNS & LOBBYING: Changes to verification programs implemented by a county election commissions.**

*Summary:* Specifies various indications for when a voter changes address of residence without notifying the county election commission. Clarifies that any online voter registrations must be submitted on or before July 1, 2017.

**SB645/HB686 CAMPAIGNS & LOBBYING: Fines for voter fraud.**

*Summary:* Requires the court to impose an additional \$5,000 fine for a conviction for voter fraud. Provides a \$5,000 reward for information leading to a conviction for voter fraud.

**SB672/HB1053 CAMPAIGNS & LOBBYING: Prohibits using public buildings or facilities for campaign activities for all popularly elected officials.**

*Sponsors:* Sen. Harris, Lee , Rep. Matlock, Jimmy  
*Summary:* Does not exclude public officers and employees from provision of unlawful use of public buildings for campaign activity for a single candidate, party, or measure.

**SB770/HB662 CAMPAIGNS & LOBBYING: Minor party recognition requirements.**

*Sponsors:* Sen. Beavers, Mae , Rep. Hulseby, Bud  
*Summary:* Deletes provision requiring the minimum number of signatures on a petition to be equal to at least two and one-half percent of the total number of votes cast for gubernatorial candidates in the most recent election of governor for purposes of qualifying as a recognized minor party. Requires a petition to bear the signatures of five thousand registered voters for purposes of qualifying as a recognized minor party. Changes the number of votes that a political party must receive for purposes of qualifying as a statewide political party from five percent of the total number of votes cast for gubernatorial candidates in the most recent election of governor to one and a half percent of the total number of votes cast for gubernatorial candidates in the most recent election of governor.

*Summary:* Requires a person to declare a statewide political party affiliation before voting in a primary election.

**SB815/HB394 CAMPAIGNS & LOBBYING: Restrictions on lobbying by state employees.**

*Sponsors:* Sen. Green, Mark , Rep. Sexton, Cameron  
*Summary:* Prohibits state employees from lobbying for 12 months following departure from office or employment.

**SB832/HB845 CAMPAIGNS & LOBBYING: Tennessee Congressional Redistricting Commission Act.**

*Sponsors:* Sen. Yarbro, Jeff , Rep. Fitzhugh, Craig  
*Summary:* Establishes a five-member congressional redistricting commission beginning in January 2021. Specifies the five appointed members. Outlines commission eligibility. Allows the commission to employ consultants as necessary to carry out its duties. Allows all records and information in possession of the commission to be open to the public. Requires the commission to develop a redistricting plan for the state. Establishes criteria for redistricting plan. Requires the commission to submit the plan to the general assembly no later than September 30, 2021. Requires the plan to be drafted as legislation to be introduced in the general assembly. Allows the commission to submit redistricting plans to the Tennessee supreme court if not enacted into law by November 1, 2021. (10 pp.)

**SB840/HB1117 CAMPAIGNS & LOBBYING: Disabled veterans voting absentee.**

*Summary:* Allows disabled veterans to vote absentee. Clarifies definition of disabled veteran.  
*Intro Dates:* S: 02/13/17, H: 02/09/17  
*Senate Status:* 02/21/17 - Referred to Senate State & Local Government Veterans Affairs Subcommittee.  
*House Status:* 02/23/17 - Set for House Local Government Subcommittee 02/28/17.

**SB877/HB1314 EDUCATION: Providing students information on how to vote.**

*Sponsors:* Sen. Harris, Lee , Rep. Turner, Johnnie  
*Summary:* Beginning in the 2017-2018 school year, requires public and private schools to provide students in grade 12 information on how to vote. Specifies that such information should include how to register to vote, how to vote in an election using a ballot, and how to vote using an absentee ballot. Allows schools to provide this information through activities, written materials, internet resources, mock elections, and any other method chosen by the principal after consultation with teachers.

**SB925/HB671 CAMPAIGNS & LOBBYING: Members of a board of public utilities to serve as a member of a county election commission.**

*Summary:* Authorizes members of a board of public utilities to serve as a member of a county election commission; prescribes the process for certifying new voting systems for use in this state.  
*Fiscal Note:* (Dated February 22, 2017) NOT SIGNIFICANT

**SB1017/HB1007 CAMPAIGNS & LOBBYING: Lobbyist gifts to candidates or officials.**

*Sponsors:* Sen. Gardenhire, Todd , Rep. Holt, Andy  
*Summary:* Removes the restriction that lobbyist gifts to candidates or officials be made for a non-business purpose if such gifts are based on a close personal friendship and authorized by the ethics commission.

*Summary:* Requires the state election commission to promulgate rules prescribing a procedure by which a qualified person may register to vote and vote on the same day during the first week of early voting in any election for which there is early voting.

**SB1026/HB954 CAMPAIGNS & LOBBYING: Registering to vote on the day of an election.**

*Sponsors:* Sen. Yarbro, Jeff , Rep. Fitzhugh, Craig  
*Summary:* Authorizes a person to register to vote on the day of the election, including any days of early voting. Requires county election commissions to make voter registration application forms available at all polling places. Allows any person who is already registered to vote to update any information on the day of election or on any day of early voting on a form prescribed by the state election commission. Declares that anyone who registers to vote on the day of of the election or any days of early voting must be permitted to vote a regular ballot. Requires the state election commission to promulgate rules for such purposes.

**SB1027/HB1310 CAMPAIGNS & LOBBYING: Voter Protection Act.**

*Summary:* Requires county election commissions to post a voter's bill of rights at every voting place, which establishes that every registered voter has the right to: inspect sample ballots before voting, cast a ballot if in line when the polls are closing, receive language assistance, ask for a new ballot if a mistake is made, cast a provisional ballot, vote free from intimidation, and to cast a ballot using modern voting equipment that accurately counts all votes.

*Summary:* Requires elections for judicial and county constitutional offices to be nonpartisan. Deletes provisions concerning primary elections for judicial and county constitutional offices. Requires run off election if no candidate receives a majority of votes cast for the office.

Allows a person who has been convicted of a felony and confined to a federal or state correctional institution in the United States to be restored the right to vote in a federal, state, county, or municipal election when that person has been discharged from confinement. Requires that when a person is restored the right to vote, the department of correction must provide that person with a voter registration form, assistance in filling out the form, and a document certifying the person is eligible to vote, and the department must deliver completed voter registration forms to the coordinator of elections. Requires the department on or before the fifteenth day of each month, to transmit to the coordinator of elections a list of persons convicted of a felony who, during the preceding period, have become ineligible to vote; and a list of persons convicted of a felony who, during the preceding period, have become eligible to vote. Adds language to state that before accepting a plea of guilty or nolo contendere to a felony, and before imposing a felony sentence after trial, the court shall notify the defendant that conviction will result in loss of the right to vote as long as the person is confined and that voting rights are restored upon discharge. Requires the secretary of state to ensure that the statewide voter registration database is purged of the names of persons who are ineligible to vote because of a felony conviction and to likewise ensure that the names of persons who are eligible and registered to vote following restoration of voting rights are added to the statewide voter registration database in the same manner as all other names are added to that database. Allows pre-trial detainees who are eligible to register and vote to be given the opportunity and assistance to do so, including assistance in securing and casting absentee ballots. Deletes language forbidding a person convicted of first degree murder, aggravated rape, treason, or voter fraud from never being eligible to vote in Tennessee.

Requires the office of legislative administration to develop a disclosure form and to receive such completed forms from members of the general assembly.

After each round, the candidate with the fewest votes is eliminated, with the votes for that candidate redistributed to the remaining non-eliminated candidates based on the order of preferences indicated on each of the affected ballots. Prohibits a county or municipality from using instant runoff voting for the purpose of conducting any primary, general, or special election.
