Apprenticeship and Training Program for Electricians

General Information

Minimum Qualifications

- Applicants must be at least 18 years of age and provide proof.
- Applicants must provide proof they have completed four years of high school or successfully passed the GED equivalent.
- Applicants shall be physically capable of performing the essential functions of the apprenticeship program without posing a direct threat to the health and safety of the individual or others.
- Applicants must be able to obtain a State of Texas Electrical Apprentice License and provide proof. (www.tdlr.texas.gov)
- Applicants must have transportation to work and school.
- Male applicants must be registered with Selective Services or have proof of exemption.

Applications

- Applications are accepted:
April 7, 2020 – July 30, 2020 for the class starting September 2020.
September 29 – December 17, 2020 for the class starting January 18, 2021.
- Applications are accepted Tuesday through Thursday from 1:00 P.M. to 3:00 P.M.
- Applications can be filled out at the IEC Chapter Office located at 5809 East Berry St., Fort Worth, TX 76119.
- Application can be filled out online.

Length of Apprenticeship

- Usually four years which includes a minimum of 8,000 of on the job training and a minimum of 576 hours of classroom work.

Minimum Required Documentation To Be Scheduled For Interview

- Documents that establish identity and employment eligibility (usually a drivers' license or photo ID and a birth certificate or social security card).
- Proof they have completed four years of high school or successfully passed the GED equivalent.
- Proof they are able to obtain a State of Texas Electrical Apprentice License.

Additional Documentation (if applicable)

- DD214 (if veteran)
- High School Transcript (if any)
- Letters of Recommendation from previous or present employers (if any)
- Evidence of previous experience in the electrical field (if any)

Interview

- All documentation must be received prior to the interview.
- Applicants who meet the qualifications of the Apprenticeship Program and provide required documentation will be interviewed by the Apprenticeship and Training Committee at a specified date.

Before Placement into Program

- After completion of interview, applicant must pay IEC a drug test fee and successfully pass a drug screen.

Pay Scale

- At this time, the starting wage is \$11.50 per hour with periodic raises based on the current wage scale.
- Based on interview score, applicants will be referred to a contractor member for a job interview and potential employment. Employment is not guaranteed, however if the applicant is hired by a contractor, the applicant will be registered to the Apprenticeship and Training Committee as soon as possible.

Tuition

- The cost to the apprentice is currently .36 cents per each hour of on the job training. (Example 40 hours x .36 = \$14.40)

This is an Equal Employment Opportunity in Apprenticeship and Training for all applicants who meet the qualifications of the program. Women, minorities and veterans are encouraged to apply.
