The NAEA Board of Directors appointed a Fiscal Impact Committee to explore the need and implications for adjusting membership dues in alignment with today's costs. This committee worked closely with NAEA leaders (including the Board of Directors and Delegates from every state) and staff to determine the best course of action. The result of the Committee's research and fact finding was that NAEA must adjust national dues. This increase will help to close the gap between the actual cost of membership fulfillment and the current dues pricing.

Looking ahead, NAEA is building on a solid foundation of core benefits and events while investing in
