As we move into March, I want to take a moment to update you on the work I've been doing at the State Capitol to make Arizona safer, stronger, and more accountable. From ensuring responsible environmental practices to improving school safety and strengthening government transparency, I remain committed to serving you with integrity and action.

✓ **Protecting Our Communities from Environmental Hazards**

I have introduced a legislative package aimed at addressing abandoned mines across Arizona, holding companies accountable for cleanup, and preventing future environmental hazards. We must ensure that businesses operating in our state respect our land and do not leave behind dangerous conditions for our communities.

✓ **Enhancing School Safety**

Keeping our children safe in schools is a top priority. I've introduced the "Save Our Children School Safety Program," which provides essential crisis management training for school employees, including de-escalation techniques, emergency medical response, and responsible firearm handling. This initiative equips educators with the tools they need to protect students in critical situations.

✓ **Strengthening Government Accountability**

Public servants should lead by example. That's why I strongly support a constitutional amendment to

limit legislative immunity, ensuring that lawmakers—myself included—are held to the same legal standards as the people we serve. Integrity in government is non-negotiable.

AZ HOUSE BILL 2182



Arizona House Bill 2182 (HB 2182) was introduced on January 21, 2025, by Representative Selina Bliss. The bill proposes that the Arizona Health Care Cost Containment System (AHCCCS) adopt rules to establish a uniform preadmission screening process for individuals with cognitive impairments seeking long-term care services under the Arizona Long Term Care System (ALTCS). As of February 26, 2025, HB 2182 passed the Arizona House of Representatives with a unanimous vote of 58-0 and was transmitted to the Senate for consideration. Congratulations!

The Freedom Festival held on March 1, 2025, at Wesley Bolin Memorial Plaza in Phoenix, Arizona, was organized by Gun Owners of America (GOA) to celebrate and advocate for Second Amendment rights. The event featured national vendors, speakers, food trucks, a Kid Zone, entertainment, and celebrity influencers, all emphasizing the importance of the right to keep and bear arms. Additionally, two \$500 scholarships were awarded to high school seniors, and attendees had opportunities to participate in firearm raffles, door prizes, and receive SWAG bags. This festival marked the first annual event under GOA's leadership, succeeding the previous 11 years of Second Amendment celebrations organized by Riders U.S.A.

What's Next

Upcoming votes, Events, Committee Hearings and Policies

HB2021 – early ballots; early voting; identification Brings confidence to Arizona elections by reducing wait times for election results. Early ballots are due by 7:00 p.m. Friday before the election. ID must be shown to drop off an early ballot on election day.

HB 2127 - hazardous substance release; notice; liability Prevents foreign countries from purchasing mineral rights to subsequently contaminate U.S. properties, the example being Senator Mine in Prescott, Arizona



HB2207 – child sex trafficking; juvenile defendants Under the 8th Amendment of the US Constitution, protects children who are victims of sex trafficking HB 2308 - vacation rentals; ordinance; limits; exemption Gives cities and towns back the ability to regulate the number and density of short-term rentals

HB 2179 - marijuana; advertising; restrictions Protects children by preventing cannabis dispensaries from targeting youths in the advertising of marijuana products

HB 2697 - Water; residential lease communities Requires the build-to-rent developers are held to the same 100-year assured water supply certificate as build-to-sell developers in active management areas
