**The Opportunity:**

Jersey Shore University Medical Center is seeking an accomplished and inspirational Chair, Department of Obstetrics and Gynecology (OBGYN) who is responsible for all professional and administrative functions within the Department. This represents an exciting opportunity to lead the growth and development of patient care services, teaching and research in OBGYN with the provider of the most advanced programs and services in Central New Jersey.

**The Organization:**

Jersey Shore University Medical Center (JSUMC) is a member of Hackensack Meridian Health. JSUMC is a 646-bed academic medical center with services that include a Level II Regional Trauma Center, a Stroke Rescue Center, and the region's only Cardiac Surgery program. JSUMC has been recognized by US News and World Report and Consumer Reports as top performers.

Hackensack Meridian Health (HMH) formed with the merger of Hackensack University Health Network and Meridian Health and is now a \$4.1 billion clinically integrated network of 17 hospitals. A strategic mission of HMH is to develop into a major academic center and in June 2015 signed a definitive agreement with Seton Hall to form a new, four-year school of medicine –Hackensack Meridian School of Medicine at Seton Hall. The flagship hospitals of HMH (HUMC) and Meridian (JSUMC) will serve as the primary clinical teaching sites.

The OBGYN Department at JSUMC is a regional leader for women's health services. The department includes 73 physicians who practice general obstetrics and gynecology, as well as sub-specialty areas including Maternal Fetal Medicine, Gynecologic Oncology, Reproductive Medicine and Infertility, and Uro-Gynecology. JSUMC also has a dynamic four-year OBGYN residency program which offers its 16 residents exposure to all the subspecialties. The Department has grown significantly and is expected to continue to grow under the Direction of the new Chair.

**The Position:**

The Chair, Department of OB/GYN at JSUMC will provide strategic, innovative and operational leadership, and will have responsibility and accountability for the clinical and academic performance of all divisions within the Department. It is anticipated that the Chair will maintain some degree of clinical practice (up to 25%), with a majority allocation for administrative responsibilities. It is also anticipated that the Chair will participate in educational activities and will qualify for faculty appointment at the Medical School at Seton Hall.

**Required background qualifications and training:**

- M.D. / D.O. degree from a recognized School of Medicine.
- Board Certification by the American Board of Obstetrics and Gynecology.
- New Jersey Medical License.
- Experience in care of women, in general or subspecialty practice.
- Administrative experience in a teaching hospital or medical school for at least five (5) years.
- Qualified for rank of attending physician at JSUMC.
- Personality and ability to deal effectively with professional peers and department members under his/her supervision.
