In addition, the VPFA will support efforts for increasing the diversity of UMMS faculty, along with creating a faculty environment that fosters inclusion and wellness. The VPFA will have primary responsibility for faculty issues including, but not limited to, development, interpretation, implementation, monitoring, evaluation, and communication of academic personnel and faculty governance policies and procedures. The VPFA will also serve as a liaison between faculty and the chairs of departments and administration, with the goal of fostering, sustaining, and maintaining the collaborative culture among all academic entities.
