The Department performs approximately 10,000 inpatient and outpatient procedures annually and provides comprehensive general and sub-specialty surgical services within a collaborative teaching hospital environment. The Hospital is a founding member of Beth Israel Lahey Health (BILH), a \$5.5B, 13 hospital health care system serving eastern Massachusetts that recently received approval from all state and federal regulatory agencies and began joint operations on March 1, 2019.

Academically the Hospital is distinguished with an ACGME accredited residency in medicine and radiology with rotating residents from within the Harvard system in numerous specialties providing a rich learning environment for all residents, students and learners. Surgeons in many specialties have achieved teaching appointments and engage in faculty research and related publications. Mount Auburn's medical staff is recognized nationally for their expertise in managed care and risk based contracting with participation in numerous commercial and governmental contracts including the Medicare Shared Savings and Medicare Advantage programs.

Candidates for this position must be eligible based on their record of accomplishments and experience to be considered for an academic appointment as Associate or Full Professor on the Harvard Medical School faculty. Board certification in surgery is required. The successful candidate will have an exceptional track record of academic and administrative accomplishment including a strong commitment to excellence, clinical quality, and patient safety along with the ability to grow and sustain a culture of collaboration, teamwork, and achievement.
