With the ACC Director, the Deputy Director of Clinical Services works in tandem with the CSL Chief Administrative Officer around strategy, operations, and change implementation.

The successful candidate will be a proven visionary who has demonstrated success in developing and growing high functioning cancer programs in clinical care and research, quality and safety, and payor relations. An ability to traverse the fields of academic and community medicine across multiple disciplines, corporate entities, and the clinical enterprise while building collaborative relationships with other leaders at the departmental, strategic, and operational level are required.

The ACC seeks faculty candidates for an Associate or Full Professor position in the non-tenure clinician-educator track.
