THE UNIVERSITY AT BUFFALO

The University at Buffalo (UB) is one of two flagship campuses in the State University of New York (SUNY) system and is its largest and most comprehensive research university. An R1 institution, UB was also among the first public universities in the Northeast and the first SUNY school to join the Association of American Universities (AAU) when it was admitted in 1989. The University is a major employer and economic driver regionally and across New York State. With \$250 million in federally funded research today, the University aims to double this number by FY2030. Growing research is at the center of UB's push to join the ranks of the top 25 public research universities. UB is also in the midst of a transformational hiring initiative that will bring at least 180 new tenure-track faculty members to campus in the next two years.

The University at Buffalo is home to a robust health sciences campus including the Jacobs School of Medicine and Biomedical Sciences, the School of Pharmacy and Pharmaceutical Sciences, the School of Dental Medicine, the School of Public Health and Health Professions, the School of Nursing, and the School of Social Work.

Jacobs School of Medicine and Biomedical Sciences

As a leading public medical school in New York State, the Jacobs School of Medicine and Biomedical Sciences (Jacobs School) has been consistently recognized for producing high quality doctors and researchers who are committed to serving the people of Western New York and creating a healthier society. As a flagship SUNY system, UB is a popular destination for New York residents seeking a medical degree, with over 80% of graduates choosing to stay in the state to practice medicine after graduation.

Education

The Jacobs School offers a broad array of education options from undergraduate programs to postdoctoral training. After years of planning, the Jacobs School's new curriculum, "Well Beyond", goes into effect July 2024. The new curriculum integrates five core pillars: foundational sciences, clinical sciences, health systems science, medical humanities, and scientific literacy and inquiry.

Research

As the research engine for UB, the Jacobs School accounts for 36 percent of research expenditure for the University. In 2023, the Jacobs School achieved \$74 million in awards with 177 new grants. A \$4 million investment from UB will boost age-related research and provide seed funding for new interdisciplinary projects. Jacobs School faculty authored or co-authored 755 peer-reviewed publications in 2023.

Department of Ophthalmology

The Department of Ophthalmology, headquartered at the Ira G. Ross Eye Institute, is committed to achieving the highest standards in education, research, and patient care, with the overarching goal of advancing the field of ophthalmology and providing outstanding care for the region. The Department's mission centers on the preservation of sight through excellence in these core areas.

Comprising highly skilled ophthalmologists and professional staff, the Department provides a comprehensive range of medical and surgical management for both routine and complex eye disorders. Specialized services include cornea and external disease, neuro-ophthalmology, oculoplastic surgery, ophthalmic pathology, pediatric ophthalmology, glaucoma, and retina and vitreous disorders. Medical residents and fellows receive training under the close supervision of experienced faculty physicians, ensuring a solid foundation in both clinical practice and advanced ophthalmic techniques.

The primary mission of the Department includes the clinical and surgical training of physicians, research and development in ophthalmology, and the provision of high-quality tertiary eye care to the people of Western New York. To fulfill this mission, the Department comprises 31 faculty members, including a core group of fellowship-trained, full-time clinical faculty and research scientists, supplemented by a dedicated group of volunteer faculty. In the clinics, as well as in laboratories on the University at Buffalo campus, dedicated researchers work to provide new knowledge that will eventually lead to advances in patient care.

The Department of Ophthalmology is committed to an inclusive and respectful environment as demonstrated by its commitment to recruitment and retention of diverse faculty, staff, and students, delivery of quality patient care for diverse populations, and implementation of research to reduce health disparities.

Clinical Care at Ira G. Ross Eye Institute

The Department of Ophthalmology is headquartered at The Ira G. Ross Eye Institute (the Institute), a world-class center of excellence for eye and vision care and research. The institute serves over 61,000 patients each year, addressing the loss of vision due to health issues, disease, or injury. Unlike other eye care providers, the Institute places a strong emphasis on education for both patients and healthcare professionals. As the only university-affiliated vision care practice in Western New York, it collaborates with University at Buffalo students to ensure access to the latest information and advancements in eye care technologies.

The Institute's team of ophthalmologists and vision care experts offers a comprehensive range of medical and surgical services, addressing various conditions from routine eye care to complex cases. By employing state-of-the-art technologies and innovative techniques, the Ross Eye Institute enhances patient outcomes and quality of

care. The mission of the Ross Eye Institute is to provide excellent patient vision care, promote community and medical education, and encourage high-impact research.

Education

The Department of Ophthalmology offers a four-year residency program that equips trainees with the necessary skills for a successful career in ophthalmology. The residency program currently has a total of nine residents enrolled.

The Department also houses the Orthoptic Program, which is fully accredited by the American Orthoptic Council. This two-year course of study provides rigorous training, allowing graduates to earn a Certificate of Completion and qualify for national board examinations.

Research

The Department of Ophthalmology has secured more than \$16 million in research funding over the past five years. In 2024, the Department ranked 38th in NIH funding among 65 ophthalmology programs in the U.S. Key funding sources include the NIH, the VA, private institutions, and industry sponsors.

The Department's research programs are continuously expanding, focusing on groundbreaking studies in areas such as gene therapy and structural biology. The Vision Research Center, part of the Ira G. Ross Eye Institute, is committed to excellence in research, medical education, and healthcare. This center focuses on developing sight-preserving treatments for conditions such as age-related macular degeneration, diabetic retinopathy, and glaucoma, aiming to reduce visual impairment and enhance the quality of life for individuals of all ages.

The Department is supported by nine dedicated research faculty who work collaboratively with scientists from multiple universities and participate in partnerships with domestic and international private research institutes and pharmaceutical companies. Additionally, the Department engages in partnerships through the SUNY Eye Institute, a consortium aimed at advancing eye research.

The Jacobs School of Medicine and Biomedical Sciences is seeking an academic ophthalmologist with unique vision, enthusiasm, and experience for the position of Chair of Ophthalmology (the Chair). The Chair will be responsible for ensuring excellence in the department's educational, scientific, and clinical programs while overseeing overall operations and strategic direction. In this pivotal role, the Chair will enhance the department's clinical mission by increasing patient volumes, promoting coordinated care, and driving ambulatory growth, all while maintaining high standards in educational and scientific initiatives. This is an opportunity to shape the clinical landscape and expand the research enterprise, building on the department's history of research success and enhancing its reputation for quality and innovation. This position offers an exciting opportunity to elevate the standard of care and redefine the future of ophthalmology in western New York.
