The Chair is expected to be a skilled, practicing surgeon who will continue their own academic activities, serving as an example to faculty and trainees. They must have a keen sense of the clinical environments, both current and future, anticipating the changes in culture, practice and strategies necessary for success.

The Chair will be an energetic and visionary leader, who articulates clearly the unparalleled potential of the department, and who leads in a way others will follow. The next Chair must be passionate about seeking consensus, but not afraid to make difficult decisions or lead change. Critically, they must demonstrate transparency, a deep sense of professionalism, commitment to diversity and inclusion in all its forms, an unwavering ethical compass, and strong support for interdisciplinary and inter-professional collaboration.

The ideal candidate will be a nationally recognized, clinically active academic surgeon with strong leadership skills, a reputation for surgical excellence, and record of achievement in clinical work,

education, research, and administration. The successful candidate will have demonstrated a leadership style that is focused on the success of the faculty in all of their endeavors; commitment to the Chair's role in institutional, as well as departmental leadership; deep understanding of the role of culture in organizational success; and a willingness to be both strategic and tactical in achieving department objectives.
