### **Membership Privileges, Notices, Disclosures & Agreement**

The undersigned ("Member") hereby purchases a Rejuv Radiance Skin Health Program membership from Rejuv Medical Aesthetic Clinic, Inc. ("Rejuv") at 3301 45<sup>th</sup> St S, Fargo, ND 58104 on the terms and conditions set forth below, and promises to pay for such membership in accordance with the terms set forth. The membership price of **\$89** includes: discounted facials and upgrades; 20% off SkinPen, BBL, Halo, Exilis, Thermiva, and Vanquish; 10% off PRP Vampire Facial and Lift, PRP Hair Restoration, and O-Shot; \$12 per unit of Botox; \$50 off each syringe of Dermal Fillers, Kybella, Sculptra and each Cool Sculpting cycle; 10% off all skin care products; birthday gift the month of your birthday – free B12 Boost (\$30 value); new member Blueprint to Beauty welcome Gift – coaching session that includes Visia Digital Complexion Analysis and orientation to all member benefits. Cash or Stash Option: monthly SkinPerfect Facial, \$89 value, can be redeemed or stashed for future purchase of skin care products or services. **Promise to Pay:** You promise to pay Rejuv or to our order, the Total of Payments according to your EFT Payment schedule shown above. Your EFT draft payment will be made to Rejuv. **Terms of Membership & Renewal Provisions:** Following the initial 12 month membership term, for your convenience, this contract will be extended on a month-to-month basis with automatic EFT credit/debit card payments. Contract cancellation requires 60 days written notice prior to your next automatic EFT without incurring additional liability of one (1) month's dues. Membership Cancellation Form must be processed in person with our Membership Specialist. Member must not be in default and must be current on fees for cancellation to become effective. Notwithstanding the terms as set forth above, Rejuv reserves the right to cancel a membership under extreme circumstance. **Utilization:** Your failure to use your Rejuv membership, the programs and facilities does not relieve you of your liability for payment. This contract is non-refundable and non-transferable. Membership pricing, promotions and offers are for the member's use only. Membership discounts do not apply to any additional discounts advertised. \_\_\_\_\_ (initial)

**Default and Late Payments:** Should you default on any payment obligation as called for in this agreement, Rejuv will have the right to declare the entire remaining balance immediately due and payable and you agree to pay the allowable interest, and all cost of collection, including but not limited to collection agency fees. A default occurs when any payment under this agreement becomes more than ten days late. Should any monthly payment become more than ten days past due, you will be charged a late fee of **\$25.00**. An additional service fee will be assessed for any check, draft, credit card, money order or its billing company returned for insufficient funds for any other reason. If the member is paying monthly dues by electronic funds transfer (E.F.T.), Rejuv reserves the right to draft via EFT all amounts owed by the member including any and all late fees and service fees. **Consumer's Right to Cancel:** 1. You (the buyer) have **3** business days to cancel this contract. To cancel, hand deliver your letter to the above listed address. To be effective, your cancellation must be 3 business days from the date this contract was signed. If you hand deliver your cancellation, be sure to get a signed statement from an official of the clinic, acknowledging your cancellation. 2. Account must be current in order to qualify for cancellation. 3. Cancellation notice must be **60** days prior to the billing date with a physically signed copy which can be delivered in person to the address listed above.
