From the President

The year 2020 is one we all will remember for a long time. It is difficult now to remember the issues that seemed so important in summer and fall of 2019. Like all of us around the world, the COVID pandemic has significantly affected the operation of Kodai International School and the Kodaikanal community. Kodai Friends International has been able to provide help to both the school and broader community with the generous support of North American alumni and friends.

It has been eight years since I joined the KFI board. It is time that I, along with several other active and long-serving board members, step down and hand over operations to a dynamic and energetic group of new and newer board members. We are fortunate that long-time board member Stan Kuruvilla has taken over as President while I complete a final year as Past President. Stan has been very active in developing a vision for our organization, including a semester spent at KIS working to strengthen our collaborative work and support for the school and community in Kodai. Several long-standing board members, including Bob Fletcher, Treasurer Mary Coleman Lowry, and Vice President Vijay Naidu, have agreed to continue their involvement with the board during this challenging transitional year. Vijay is taking over as Treasurer following many excellent years of service by Mary in that role.

During the winter and spring, as KIS dealt with the significant changes resulting from the pandemic, the board continued the efforts to partner more collaboratively with KIS. President Stan hit the ground running, and along with proactive board members including David Piet (who spent the spring semester at the school), Jane Cummings, and KFI Administrator Sylvia Trautmann Rogers, began strategizing and organizing activities. A strong group of new board members, attracted by Vijay as head of the Nominating Committee, have joined the board: Maureen Aung-Thwin '66, Meg Greene '79, Basanthi Gopalakrishnan Bergener '86, and Kathy Johnson Narney '71.

So I leave the board in good hands and with thanks for the excellent volunteer work that board members and many alumni have and continue to provide through Kodai Friends International.

The KIS Archives are now online!

The KIS website, [KIS Archives](#), contains a treasure trove of stories, pictures, notable persons, and memorabilia related to the history of Kodaikanal International School. Click on this site and risk getting lost in this world for several hours!

Some of the highlights of the Archives include a collection of school yearbooks, "The Eucy," beginning in 1940, and an assemblage of historical photographs of Kodai and its early (white) settlers. These include pictures of transportation up the Coolie Ghat, views from Coaker's Walk, and sights around the Kodai lake and township. In addition, there are class pictures through the years, beginning in 1901, and recipes from the 1950 (5th edition) High Clerc Cookery Book. (Porcupine meatballs, anyone? Page 49!). At present the Archives house Eucys from 1940 through 1999, but uploading continues so keep checking. Just a glimpse of all the different front cover designs of the Eucys through the ages is a treat.



In response to a grant request from KIS for the funds remaining in the Archives Fund, originally established by the Class of 1961, \$4,175 was sent to help pay the part-time salary of Barbara Block, Class of 1976, to continue work on the archives, especially the Nora Mitchell Collection. The Nora Mitchell Collection was a large bequest made to the school after Nora, a much-loved and highly respected teacher from 1964 to 1986 died. Besides being an excellent teacher of German, Indian Social Studies, and Geography, she was an avid traveler. The collection includes her travelogues and pictures, beginning in 1951 with her European travels, through her arrival in India in 1956, to what appears to be her last trip in 2000 when she was living in London.

Barbara Block is not only cataloguing this collection but is bringing the KIS Archives to the attention of students, staff and alumni around the world. She and Manjusha Ninan, KIS Alumni Coordinator, wrote an article for the "Flag Green" about the Nora Mitchell Collection which can be viewed at [The Nora Mitchell Collection - KIS Flag Green](#). They have also very creatively initiated an all-school photo competition which involves cooking a recipe from the High Clerc Cookery Book and submitting a photograph of it. Barbara can be seen presenting the cookbook to the students at a weekly "Vanakkam" (assembly) at [Barbara Block Presents KIS Archives](#).

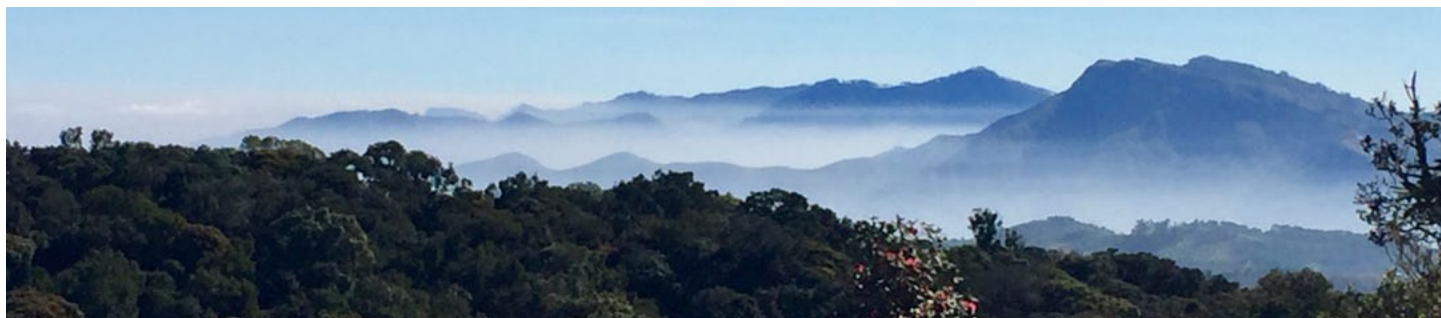
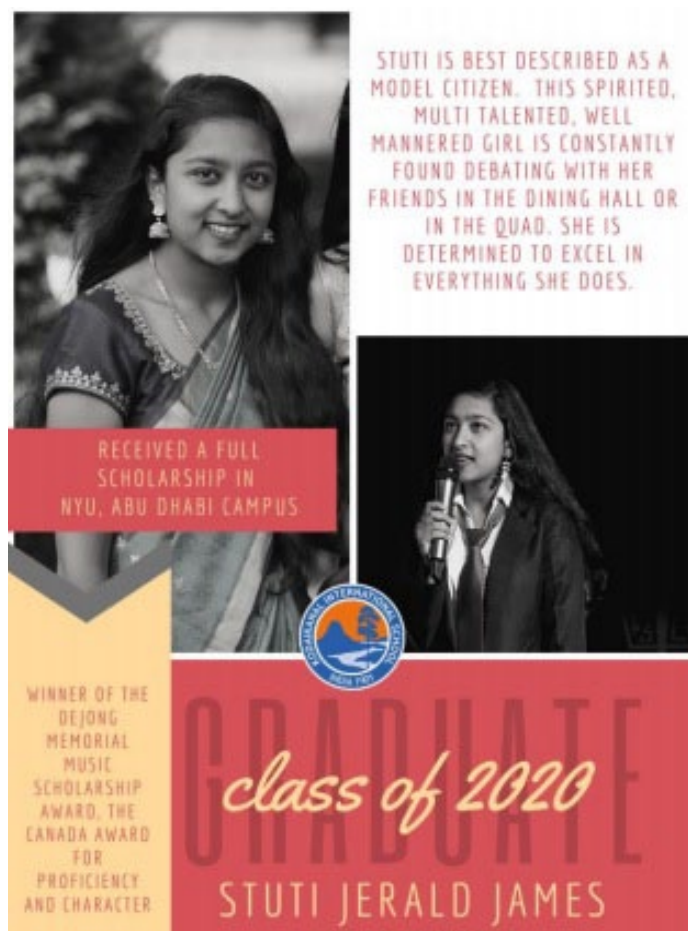

Grants Awarded by KFI in 2019-2020

KIS Emergency COVID-19 Relief Fund | \$41,368 (March – June 2020)

In June 2020, Principal Corey Stixrud wrote “There has never been a moment in the history of Kodai School and in Kodaikanal quite like this one. Like many institutions across the world, KIS faces a cloudy and uncertain future. Similarly, Kodaikanal and its surrounding communities face the same uncertain and dire future.”

In March of 2020, the KIS Emergency COVID-19 Relief Fund was established to provide funds to overcome the immediate crisis imposed by the pandemic on KIS, maintain admissions, and support the local community. KIS identified two main areas in which funds will be used: (1) need-based scholarships for KIS families; and (2) support for the local Kodai community.

Support for the Kodai Community

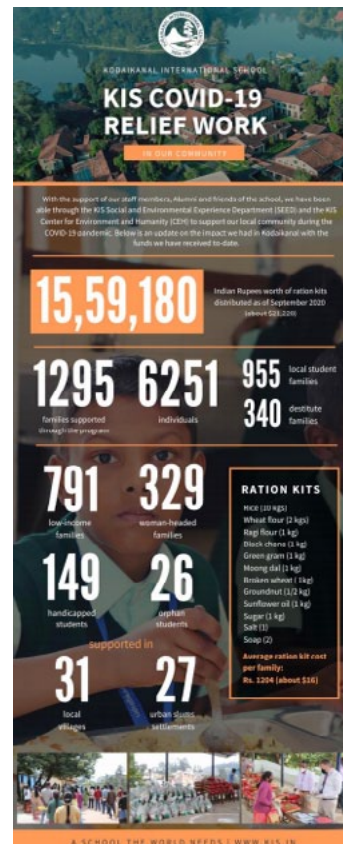
The pandemic has and will continue to greatly affect Kodaikanal’s population which relies primarily on its agricultural sector, small shops/stalls, and tourism, all of which have been devastated.

Before the COVID-19 pandemic, life and small-scale commerce in and around Kodai was stable and provided a decent income, especially during the lucrative tourist seasons. But during and after the lockdown futures and livelihoods have been put in jeopardy since India’s vast informal workforce had no safety net, not even the bare minimum. Most workers had no job protections, unemployment benefits or health insurance which left them very vulnerable when there is a crisis like COVID-19.

In response to the onset of the pandemic and the March 25th nation-wide lockdown, KIS immediately established an Emergency KIS COVID-19 Relief Fund to address the plight of poor individuals or families in need. Many people in Kodai and the surrounding villages – day laborers, widows, farmers, taxi drivers, firewood collectors, housemaids, physically disabled rag pickers, migrant workers – no longer had incomes and their families faced hunger and deprivation on a large scale.



In late May, KIS sent out an appeal letter to KIS alumni and friends around the world seeking donations to allow KIS to continue its crucial support of those most in need in Kodai and surrounding villages. The appeal letter also included a “Double Your Impact” Challenge stating that “your donation to the Relief Fund will be matched up to \$20,000 by the Daryl Miller/Len Betz Class of ‘71 Challenge.” Within a month, 55 KIS alumni and friends responded to the challenge, enabling KIS to continue its crucial support of those most in need in Kodai and surrounding villages.



An update from KIS in June, 2020 reports, “The School, individual staff members, and students have also been engaged in supporting our local Kodai community. About 150 current students launched a crowdfunding online appeal, and together with a grant from KFI for community relief, have raised support for KIS involvement with the community. These funds have allowed us to:

- Provide over 6,000 individuals with a month’s supply of food
- Renovate a wing for COVID-19 patients at the local government hospital
- Purchase an oxygen generator for Van Allen”

- Increased interaction with local schools to provide guidance, expertise, and infrastructure relating to educational and online technology to ensure that education continues when schooling is disrupted. KIS Need-Based Scholarships

As the COVID-19 pandemic swept around the world, many countries imposed varying degrees of closure. On March 25, India imposed one of the strictest lockdowns in the world which lasted through the end of the 2019-2020 school year, and beyond.

Given the uncertain nature of the coronavirus, both globally and in India, and the interwoven difficulties/uncertainties in determining the course of action to take for the upcoming academic year, Principal Corey, along with his Senior Management Team (SMT) and the KIS Council, determined in late April 2020 that a series of scholarships be awarded to students of families impacted by the pandemic.

In May 2020, KIS informed parents that short-term need-based scholarships were available, with an initial deadline for the application of June 12. At that time, KIS received 58 applications that covered 66 students. The amount requested was Rs. 3.36 Crores (or about \$444,000). KIS started vetting applications and, while it was unlikely that it could meet all requests, they continued to receive additional applications as families continued to be adversely affected by the pandemic. KIS decided to offer short-term scholarships that would be dispersed in two allotments: the first in July 2020 and the second in January of 2021. They anticipated further needs based on the duration of the pandemic and the decline in the economy. Travel restrictions also remained a concern: if students are unable to return to campus, KIS could offer them a one-quarter or one-semester scholarship to remain a student at KIS and take online classes. The student would return to KIS for Semester 2 as a condition for receiving the scholarship.

Awarding short-term scholarships provided a critical support to KIS families impacted by the pandemic. Access to these funds allowed KIS to minimize the use of fixed costs and reserves which, if necessitated, could lead to revenue losses, staff cuts, disruption, and the "loss of muscle and bone."

Charles & Nancy Wilder "Understanding Through Diversity" Fund | \$158,255

In an effort to support KIS with the daunting financial requests it has and continues to receive, KFI determined that the requirements connected with the Charles E. and Nancy E. Wilder *Understanding Through Diversity* Fund could be used to support the short-term scholarships with the following objectives in mind:

- To maintain diversity at KIS by providing scholarships to students from across the globe and from diverse regions of India.
- To maintain school admission numbers (fee-paying students) at a minimum of 320 students for the 2020-21 school year.
- To help meet the financial needs of a minimum of 58 KIS families for the 2020-21 school year.

Charles Wilder was a student at Kodai School from kindergarten through 12th grade, graduating in 1942. Seventy-four years later Kodai Friends International received this incredible gift from Charles and his wife Nancy.

As daughter Inga writes,

My father, Charles Wilder, intended to leave this gift to the New Hampshire Charitable Foundation for the benefit of the Kodaikanal International School to promote understanding among people of diverse cultures, religions, races, ethnic or geographic backgrounds. Dad strongly believed that education that promotes this understanding was the most fundamental means to promote peace and end violence. His gift demonstrates his confidence in the ability of the Kodaikanal School to provide this type of education.

The following letter written by two of his brothers (all four brothers – John, Class of '44, David, Class of '46, and Don, Class of '49, attended the school) gives some indication of the impact of the school on their lives.

Dr. Charles E. Wilder shared with all three of his younger brothers a profound appreciation for the precollege educations they received at Kodaikanal School, the precursor of Kodaikanal International School. His generous gift to KIS testifies to the impact that Kodai School had on him, an impact that remained with him throughout his life, as he never ceased to attend reunions of his Class of 1942.

His gift to KIS shows his gratitude for the solid educational preparation for college and for adult life that Kodai School provided, as well as for lasting friendships and memories of social, athletic, hiking, camping, and boating activities on the lake and in the surrounding hills.

Treasurer's Report

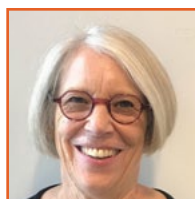
The COVID-19 epidemic has affected the entire world, including KFI. One of the two streams of income for KFI is investment income. Surprisingly, COVID-19 has not brought a decline in the market. The stock market continues to climb. The other income stream is donations. They were down by \$17,590 from the previous year. On the other side of the equation, grants, KIS requested a large infusion in grant money. The School faces challenges that arise in a virtual world where students are no longer on campus and families explore alternatives to in-person education. To help the School weather the epidemic, KFI has approved over \$200,000 for scholarships in the 2019-20 fiscal year. Most of the money from this cash infusion came from the Charles E. and Nancy E. Wilder Fund of the New Hampshire Charitable Foundation which gave KFI a gift of \$157,080 in the fiscal year 2016-17. (Interesting fact: The students who received aid, in recognition of the source of their funding, are called "Wilder Scholars.") Another ongoing source of income is an annual pay-out from the Muysken Fund at the Presbyterian Foundation. This year we received \$12,004 from the Fund. We are deeply grateful to the Wilder family and the Muysken family, alumni from the 1940's.

Summarizing the financial picture, restricted and unrestricted donations were \$67,002, down from \$84,592 in the prior year (a decrease of \$17,590). Gains in our investment accounts were once again positive, higher than the previous year, \$180,781 compared with \$160,111 the prior year.

During fiscal year 2019-20 operating expenses were \$282,322 which includes grants, administration and fundraising costs. This compares with \$161,776 the prior year. The increase reflected more generous grants to KIS, \$221,133, compared with \$92,526 the previous year, an increase of \$128,607. A total of \$208,255 was given for COVID-19 relief which included \$6,894 for the local community. Overall net assets decreased by \$68,443 over the course of the 2019-20 fiscal year.

It has been my pleasure to serve KFI as Treasurer for six years. I step down with gratitude for the many opportunities to re-connect with Kodai alumni and the opportunity to give back to the School, and with appreciation to Vijay Naidu for being willing to take over the reins as Treasurer.

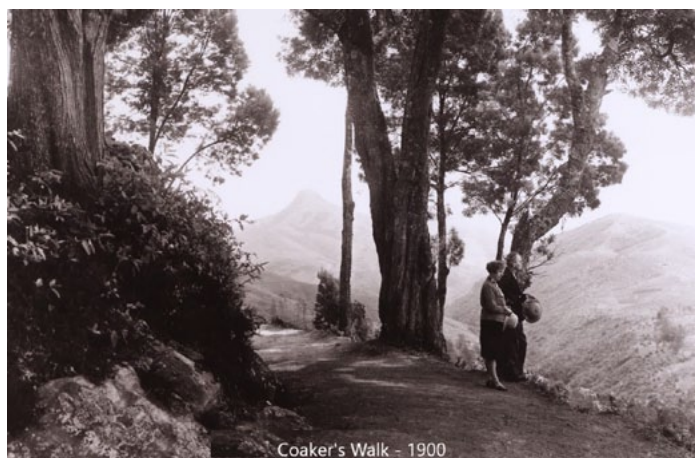

List of KFI Established Funds

(Following is a list of unrestricted and temporarily restricted funds held by KFI. Unrestricted funds are used for priority needs identified by KFI; temporarily restricted funds are restricted to the purposes for which the fund was established. All funds are disbursed by the Board of Directors of KFI in response to grant requests it receives.)

Fund a Need: This is an unrestricted fund that enables KFI the flexibility to support projects, programs and scholarships for which temporarily restricted funds are not available or to fund new initiatives.

KIS COVID-19 Relief Fund: This temporarily restricted fund was created in partnership with Kodaikanal International School (KIS) in addressing the critical needs of both the school community and the Kodai community at this time. Your gift to KFI to the KIS COVID-19 Relief Fund will enable us to respond to two critical needs:

1. Community Relief & Education
 - To support the program by the KIS Center for Environment & Humanity and the Social & Environmental Experience Department which provides food and basic supplies to those most in need in the Kodai community.
 - To support the KIS Education in Kodai Project, a short-term and long-term initiative to provide quality education, resources and infrastructure to the local schools in and around Kodai.
2. KIS Scholarships: To provide scholarships for KIS families as well as new students facing uncertain financial circumstances to ensure the continuation of their education as well as the diversity of the school body.

KIS Scholarship Fund: This is a temporarily restricted fund originally established by KFI during the Centennial year of KIS and is one of the four KIS Annual Appeal funds for 2019-20. It provides scholarships to students who meet the school's financial aid and scholarship requirements and are approved by KFI.

Russell De Valois Scholarship: This temporarily restricted fund was established by the KIS Class of 1943 in memory of their classmate, Russell, who was killed in a car accident returning from a KIS class reunion. The scholarship is offered every other year to a student in the junior and senior years who meets the donor-designated scholarship requirements.

Keith DeJong Music Award and Scholarship: Established through a legacy gift by alumnus and long-time music teacher Keith DeJong '46, and his wife Marcine, the music award is given annually to two outstanding KIS Grade 12 music students, and the music scholarship is granted to provide financial assistance for a deserving student to attend music field trips or for additional instrument lessons.

KIS Center for Environment and Humanity: This is a temporarily restricted fund which supports key initiatives in waste management, conservation, restoration, and environmental education at KIS and in the Kodaikanal community. It is one of the four KIS Annual Appeal funds for 2019-20.

KIS Design and Innovation Fund: This temporarily restricted fund was established by KFI in 2019 in support of the new program at KIS which provides students the opportunity to bring their ideas to life in a variety of Science, Technology, Engineering, Arts & Maths (STEAM) forums and competitions. This is one of the four KIS Annual Appeal funds for 2019-20.

KIS Experts-in-Residence Fund: This temporarily restricted fund was established by KFI in 2019 in support of the new program at KIS that enables experts and industry professionals to visit and work directly with students and staff for a semester at KIS. This is one of the four KIS Annual Appeal funds for 2019-20.

Sandra Schoeninger Fitness Center: This temporarily restricted fund was established to support the Fitness Center at KIS named in honor of Sandy Schoeninger, the committed, long-serving and well-remembered head of the physical education program at KIS.
