# Petition to Recognize Public Works Employees as First Responders in New York State

To: The Honorable Members of the New York State Legislature

Subject: Official Recognition of Public Works Employees as First Responders

We, the undersigned residents and stakeholders of New York State, respectfully petition the Legislature to pass legislation that formally recognizes employees of the Department of Public Works (DPW) as First Responders.

Why This Matters:

DPW personnel are on the front lines during emergencies, natural disasters, severe weather events, and public safety crises. Their roles are vital to maintaining infrastructure, ensuring safe transportation, restoring utility services, and supporting police, fire, and EMS operations.

#### **DPW Workers:**

- Respond 24/7 during snowstorms, floods, and Emergency Support Requests.
- Clear roads for ambulances and fire engines to respond during emergencies.
- Repair and maintain essential services such as water, sewage, and traffic control.
- Remove debris, secure hazardous areas, and assist in emergency evacuations.

- 2. Ensure DPW employees receive the associated benefits, training, and resources consistent with their responsibilities in emergency and disaster response.
- 3. Acknowledge their role in maintaining public safety and critical infrastructure before, during, and after emergencies.

The essential, life-saving work of DPW employees must be recognized, respected, and supported. In the face of increasing climate challenges and infrastructure demands, now is the time to act.

We call on our elected officials to do what is right and ensure that the brave and dedicated men.
