

BIOGRAPHIES OF THOSE SLATED FOR THE 2017-2019 LWVIL BOARD OF DIRECTORS AND NOMINATING COMMITTEE

Officers:

President: Bonnie Cox is a founding member (1981) of the LWV-Jo Daviess County and has served as its president from 1999 to 2001 and again from 2010 to 2016. She was elected to the board of LWV-Illinois in 2013. She's proud of the role the LWV-Jo Daviess County has played in developing a "Water Resource Management Plan" for Jo Daviess County, a project that was awarded the Effective Community Engagement Award at the LWV-US Convention in 2016. She also spearheaded the organization of the LWV-Upper Mississippi River Region Inter League Organization founded in 2015. Bonnie is retired from a career as mental health therapist and teacher. She resides with her husband John (a proud and dedicated LWV member since 1981) in historic Galena. They are blessed with three children and seven grandchildren.

Vice President: Sharon Alter has been a League member since the 1990s and served as 2015-2017 LWVIL Board Director/Voter Service Co-Chair and 2013-2015 LWVIL Board Director/Issues Co-Chair. As 2015-2017 Voter Service Co-Chair, she (1) drafted a successful \$50,000 grant proposal (with Mary Schaafsma & Jan Dörner) from McCormick Foundation; (2) updated/revised 30-page Illinois Student Vote for Fall 2016 elections; (3) assisted with League Fall 2016 high school mock elections; (4) worked with Just Democracy coalition in support of automatic voter registration in Illinois; (5) was LWVIL liaison with BallotReady voter information. As 2015-2017 Development Committee member, Sharon was co-chair of 2015 LWVIL State of the State and has been 2016-2018 LWVIL Fundraiser Co-Chair for LWVUS 2018 Convention in Chicago. In addition, she has been 2013-2015 and 2015-2017 LWVIL Nominating Committee member, Equal Rights Amendment Issue Specialist, and member of ad hoc 100th Anniversary Committee. In Fall 2015, she conducted briefing on LWVUS Constitutional Convention Study for LWV Chicago. Previously, Sharon was LWVIL Pension Study Committee Chair and LWVIL Constitutional Convention (Con-Con) Study Co-Chair. She is Professor Emeritus of History & Political Science at William Rainey Harper in Palatine.

Vice President: Hilary Denk has served on the Board of LWVIL since June of 2015 as Co-Chair of the Issues Committee, and in that capacity has pursued the implementation of the position adopted at the 2015 Convention regarding consolidation of governmental entities. She has convened a sub-committee to utilize the position for review of legislation and assist local Leagues in education and advocacy on this hotly contested regional and state issue, as well representing LWVIL with Transform Illinois. Hilary is assisting the Lake County League in developing a template for replicating their successful program increasing statewide use of the Illinois Violent Death Reporting System, managed in Illinois by the Lurie Healthcare System and supported partially by Joyce Foundation funding, to be used in other states in the region supported by the Joyce Foundation. Hilary has faithfully attended and contributed to the State Board of Directors' meetings and Issues Committee meetings, chairs the Bylaws Review Committee for the 2017 Convention and was the lead organizer for the 2017 Issues Briefing.

Hilary authored the chapter about the progressive income tax in the locally published book, "Chicago Is Not Broke- Funding the City We Deserve", and since the book launch last July, has participated in ten local events, including a Chicago City Hall press conference she organized where the LWVIL President and LWV of Chicago President both spoke. Several Leagues are also hosting events featuring this book, now in its second printing. Hilary has also assisted with membership development and the 2016 State of State fundraiser. Prior to joining the LWVIL Board, Hilary was Co-President of the LWV of Downers Grove, Woodridge & Lisle and still holds a local board position as Program Co-Chair. Hilary has been a licensed attorney for 25 years, a trained mediator for 10 years and is Vice President of the Board of Directors for SCARCE, a DuPage County environmental education and policy organization.
