**A LOCAL LAW TO AMEND CHAPTER 110 -- ZONING --
2019 ZONING MAP SUPPLEMENTAL AMENDMENTS**

Be it enacted by the Village/Town of Mount Kisco of the County of Westchester as follows:

Additions are reflected with Underlining,
Deletions are reflected within ~~Strikethrough~~

Section 1. Title

This local law shall be known as the 2019 Supplemental Amendments to the Zoning Map of the Village/Town of Mount Kisco.

Section 2. Purpose

The Zoning Map of the Village/Town of Mount Kisco is being amended as shown on the attached map to implement three minor changes identified after the public hearing closed on Local Law No.1 of 2019 which included amendments to the Zoning Code and Zoning Map as part of the Village/Town of Mount Kisco Comprehensive Plan adopted by the Village Board of Trustees on February 4, 2019. Specifically, this law changes the zoning district designation for the following tax parcels:

Section 3. The Code of the Village/Town of Mount Kisco Chapter 110 Zoning, Article II Establishment of Districts; Map §110-3 Zoning Map, is hereby amended as follows:

§ 110-3. Zoning Map.

The boundaries of said district are hereby established as shown on the Zoning Map, Village/Town of Mount Kisco, dated ~~October 1997~~ May 17, 2019, which accompanies this law and which, with all explanatory matters thereon, is hereby adopted and made a part of this chapter. Said map, indicating the

latest amendments, shall be kept up to date in the office of the Village Clerk for the use and benefit of the public. A copy of said map shall be kept on file in the office of the Village Building Inspector.


Section 4. The Village Clerk shall cause the amendments effected by this Local Law to be incorporated into the Code of the Village/Town of Mount Kisco.

Section 5. Should any section or provision of this Law be determined by any court of competent jurisdiction to be unconstitutional or invalid, then such section shall be null and void and shall be deemed separable from the remaining section(s) of this Law, and such determination shall in no way affect the validity of the remaining sections or provisions of this Law.

Section 6. This Law shall become effective immediately upon its filing with the Secretary of State of the State of New York.
