CVBIA will obtain a permit for alcohol; no individual permits are required.

A table will be provided if needed. Set-up begins at noon, Friday, May 15, and must be completed by 3 p.m. Break-down of your tailgate space can begin at 7 p.m. when the event ends.**

**PLEASE NOTE:** This is an ADULTS-ONLY event; absolutely no one under 21 is permitted to attend or work the event. (That includes infants and toddlers in strollers or carry sacks.) Event will be held rain or shine; there is no rain date scheduled.
