EXECUTIVE SERVICE CORPS: The members of the Executive Service Corps conducted 43 interviews and worked with responses from Survey Monkey. **There are Ten Basic Responsibilities of a Non-Profit Board:** Determine mission and purpose; Select the chief executive; Support and evaluate the chief executive; Ensure effective planning; Monitor and strengthen programs and services; Ensure adequate financial resources; Protect assets and provide proper financial oversight; Build a competent board; Ensure legal and ethical integrity; Enhance the organization’s public standing.

- **The Key Findings** from the interviews, documents and survey are 4 Critical Areas (**1-Selecting a Board; 2-Building a Competent Board; 3- Effective Planning; and 4-Adequate Financial Resources**).

Your board of directors will be attending a retreat on April 1 to address these Four Critical Areas. We will continue to report to you to better your chamber with opportunities needed to grow your business.
