UPDATE – “Employer Paid Sick Leave for Residents of Cook County”.

Dear Business Owner:

On June 29, a proposed ordinance was introduced to the Cook County Board of Commissioners that calls for establishing ***“Employer Paid Sick Leave for Residents of Cook County”***. <https://cook-county.legistar.com/立法Detail.aspx?ID=2775571&GUID=CCBEEF29-D744-4015-91A1-7948EEE28668&Options=&Search=&FullText=1> (you will need to copy and paste this into your browser) This ordinance, if passed, would directly impact every single business within Cook County, regardless of size. As a small business owner myself, I can't imagine how this mandatory government regulation would not place a greater financial burden on local businesses. Moreover, I can foresee this ordinance creating a competitive disadvantage for suburban Cook County businesses that compete with the collar counties and neighboring states.

I'm very appreciative of the feedback my office has already received from numerous communities, business organizations and individual businesses expressing their concern with the impact this mandatory regulation could have on Cook County businesses. At this time, I'd like to provide you with an update on the status of this proposal.

The Paid Sick Leave proposal was not called for action at the September 14 county board meeting but still remains in the Finance Committee. Please find attached the latest version of the proposed ordinance and I have been advised by the sponsors that it will be called at the next county board meeting scheduled for Wednesday, October 5 with the intention to force through a vote.

I would urge your organization and its membership to attend en masse the **Cook County Finance Committee Meeting on Wednesday, October 5 at 10:00am** to provide testimony on the impact this ordinance (**Item #16-4229**) will have directly on your business community. It's vital for the entire county board to hear directly from the people who will be heavily impacted by this mandatory regulation. My office will continue to closely monitor this issue and keep you informed of any new developments.
