# 2019 Overview

- Legislature advanced a broad agenda:
  - Healthcare
  - Housing
  - Education
  - Wildfire
  - Public Safety



# 2019 Budget Actions

- \$214 billion spending plan:
  - Schools and higher education, housing and homelessness, healthcare and families
  - \$19.2 billion for “rainy day fund”
  - \$225 forest health and wildfire prevention
  - \$200 million for Salton Sea
  - \$70 million for voluntary agreements

# Human Right to Water

- Funding for Disadvantaged Communities
  - SB 200 (Monning) – chaptered
- Governance
  - AB 134 (Bloom) – two-year bill
  - SB 414 (Caballero) – two-year bill





# SB 1 (Atkins)

- “Trump Insurance” bill
- Prevent rollbacks
  - Clean Air Act
  - Clean Water Act
  - Endangered Species Act
  - Worker Safety Laws
- Vetoed September 27



# Delta-related Legislation

- Oversight of Delta Conveyance
  - SB 204 (Dodd) – two-year bill
  - AB 1194 (Frazier) – two-year bill
  - AB 1580 (Levine) – two-year bill
- Invasive Species
  - AJR 8 (Quirk) – chaptered



# Groundwater Legislation

- AB 658 (Arambula): chaptered
- AB 441 (Eggman): two-year bill





# Drinking Water Quality

- Constituents of Emerging Concern
  - AB 756 (C. Garcia) – chaptered
- Maximum Contaminant Level (MCL) Compliance
  - AB 1204 (Rubio) – two-year bill





# Recycled Water

- Advancing Potable Reuse
  - AB 292 (Quirk) – two-year bill
  - AB 1180 (Friedman) – chaptered
- Ocean Discharge
  - SB 332 (Hertzberg) – two-year bill



# Water Conservation

- Water Use Efficiency
  - AB 1414 (Friedman) - chaptered
  - SB 134 (Hertzberg) - chaptered
- State Tax Exemption Turf Rebates
  - AB 533 (Holden) – two-year bill
- Data Sharing
  - AB 654 (Rubio) – two year bill



# Bond Funding

- 2020 Wildfire and Water Bonds
  - AB 352 (E. Garcia) \$3.92 billion general obligation bond
  - AB 1298 (Mullin) - unspecified amount
  - SB 45 (Allen) - \$4.189 billion G.O. bond
  - Private initiative filed by Joe Caves - \$7.883 billion
