The OSWR must be notified of all grant submissions prior to submissions, including:

- Grants submitted by other units across campus on which you are a Co-I, evaluator, etc.
- Grants on which UA is a subawardee
- Contracts
- Non-Traditional submissions, such as proposal solicited by a foundation or other agency
- Fellowships

Submission Deadlines.

- Finalized budget and IPF to OSWR seven (7) business days before the sponsor deadline for in-house review
- All finalized documents to OSP five (5) business days before the sponsor deadline for final review
- Submission deadline two (2) business days before sponsor deadline
- Stated FOA deadlines past 5:00 p.m. will have an internal deadline of 5:00 p.m.
