REMINDER: Operation Expanded Testing

The U.S. Department of Health and Human Services (HHS) has established <u>Operation Expanded Testing</u> to provide fully-funded COVID-19 PCR testing for K-12 schools, child care providers, HBCUs, congregate settings, and underserved populations. Through an agreement with HHS and the Department of Defense (DOD), Eurofins Clinical Enterprise is able to offer no cost COVID-19 testing to states throughout the northeast and south regions as well as D.C., Puerto Rico, and the U.S. Virgin Islands. UPDATES FOR FUNDING AND ENROLLMENT

REMINDER: School Readiness Tax Credit (SRTC) Updates

Type III licensed providers will receive their Provider Tax Credit notice in March. This notice shows the average number of CCAP children and an amount for the children served at your center in 2021. This notice will be mailed to your center.

Teachers and directors should have received tax form R-10615 "For Child Care Director and Staff Member" from Louisiana Pathways. For 2021 tax credit amounts for teachers and directors visit Louisiana Pathways. Also, remind your families of their SRTC eligibility by using this <u>flyer</u>.

For tax filing assistance, please dial 211 to learn more about the VITA (Volunteer Income Tax Assistance) Program and make an appointment to file your tax return.

REMINDER: CCAP Family Redetermination Extensions

To ensure families continue to receive CCAP services, in light of the COVID-19 pandemic redetermination cases have been extended for a three month period:

- January cases have been extended to April 30, 2022
- February cases have been extended to May 31, 2022
- March cases have been extended to June 30, 2022

NEW: America Rescue Plan Act (ARPA) Stabilization Grant - Round 2

The ARPA Stabilization Grant Round 2 will be released March 24, 2022 and will close April 7, 2022. Payments will be released on a rolling basis beginning May 2022. Providers must be operational and serving children by March 31, 2022. Please note that for all grants, providers must keep receipts and documentation of expenditures for the items paid from these funds. Also, providers must submit audit documentation upon request even if the provider has closed.

REMINDER: Information on Timeframe and Uses of ARPA Grants

The Department issued this <u>letter</u> in response to questions about the timeframe of use of the ARPA Stabilization Grants. Included in the letter is the list of allowable uses with additional details. Please be reminded that ARPA Stabilization Grant funds may not be used for construction or major renovations, including land purchases.

REMINDER: Federal and State Taxes on LaCAP Grants, ARPA Grants, Etc.

Grants provided through the stimulus funds (CARES, CRRSA, and ARPA) are subject to the same tax rules as regular CCDF funding. State tax rules apply; regarding federal rules, please contact the Internal Revenue Service for guidance. In some cases, funds used to cover operating expenses may be exempt from taxation.

NEW: LaCAP Grant Provider Survey - Next Stage

The Department has partnered with Postlethwaite and Netterville (P&N) to collect information regarding the use of Louisiana Child Care Assistance Provider (LaCAP) Relief Grant Round 6 funds for CCAP certified providers and Rounds 1 & 2 funds for Non-CCAP certified providers.

The survey was released March 8 - 10, 2022 and is to be completed by March 24, 2022. Release of ARPA Stabilization Grant Round 2 funds will be delayed for providers who have not complied with audit survey 1, 2 and/or P&N assessment request.

REMINDER: CCAP Underutilized Authorizations for Families and Paying on Enrollment CCAP conducts a monthly review of underutilized authorizations of children who have not attended child care within the previous month. The Tracking of Time Services (TOTS) Point of Service (POS) and Interactive Voice Response (IVR) attendance records are examined as part of the underutilization review. If a CCAP child has not attended at least one day in the month, the family is pulled for underutilization review.

The Provider Help Desk staff has been informing providers of the importance of families completing check in/out transactions when children are in attendance to maintain CCAP certification. If CCAP children are not attending, the Department will contact families to assess the need for continued child care services. If families are not reached during this period, their CCAP authorizations will be discontinued at the end of the month, and they will need to reapply for CCAP.

As a reminder, CCAP payments are based on enrollment, not daily attendance. **Again, the Tracking of Time Services (TOTS) Point of Service (POS) or Interactive Voice Response (IVR) must be used for CCAP children every day they are in attendance.**

UPDATES FOR LICENSED CENTERS, FAMILY CHILD CARE, AND IN-HOME PROVIDERS

NEW: Email Contacts for Providers

All providers should ensure that the center's email address shared with the Department is an e-mail address specific to the center rather than specific to the center director or other staff member, in the event the director is no longer associated with the center. To request an update to your center's email address, please email your licensing consultant or ldelicensing@la.gov.

NEW: Motor Vehicle Passenger Checks

It is imperative that vehicles are adequately inspected for children before staff exit the vehicle, especially as temperatures rise outside.

A staff person shall

- physically walk through the vehicle and inspect all seat surfaces, under all seats, and in all enclosed spaces and recesses of the vehicle interior.
- record the time of the visual passenger check and sign the log indicating that no child was left in the vehicle.

Please ensure staff have received proper training and repeated training if needed.

NEW: Decrease in Two-Year-Old Child to Staff Ratio for All Center Types

Effective July 1, 2022, the child to staff ratio for two-year-olds will decrease from 11:1 to 10:1. Ensure you have sufficient staff to meet this requirement.

REMINDER: Child Care Management Software Initiative (CCMSi)

Would you like to save time on administrative tasks? Would you like to get paid more quickly? Using specialized software (Child Care Management Software, or CCMS) can help you save time and improve your cash flow and a whole lot more! CCMS tracks child attendance, automates electronic tuition collection, eases daily parent communication, and so much more! If you are a Type III or a CCAP-certified family child care provider, you can purchase a new subscription to an approved CCMS identified in the LDOE CCMS Guidebook and receive a one-time reimbursement of up to 80% (for a maximum reimbursement of \$1,000). REMINDER: Tax Consultation

Child care providers have experienced changing finances that directly impact their taxes. The Department has contracted with tax professionals to provide support services to licensed early learning centers and CCAP-certified family child care providers. These early childhood-trained tax professionals will provide up to two hours of tax consultation, at no-cost, to early learning providers of all license types (I, II, III and FCCs).

Consultation can help you:

- Understand how loans and grants have impacted or can impact your taxes
- Use or understand payroll systems and bookkeeping software such as QuickBooks
- Proactively prepare for the current tax season
- Handle or develop a plan to handle any tax concerns or questions you might have

REMINDER: Early Learning Provider Business Training

The Department is offering business trainings through First Children's Finance through March 2022 for all licensed child care types and CCAP-certified family child care providers. Additionally, business consultation hours are available through June 2022.

These business training and consultation offerings are intended to help providers grow their businesses, stay on top of finances, increase earning potential, and so much more. The one-on-one consultation hours offer providers a unique and valuable opportunity to ask even more in-depth questions about their individual business.
