Dear Colleagues,

We hope everyone had a great holiday season. Unfortunately, during the season, COVID-19 has not taken a break. With the Omicron variant, the spread has significantly increased. Most early childhood programs serve children in an age group that is not yet eligible for vaccinations. Therefore, it is important to use multiple COVID-19 prevention strategies to protect children and adults in early childhood programs. On January 4, the Office of Public Health published [updated guidance for child care facilities](#).

Some highlights include the following:

- The CDC has issued revised isolation and quarantine guidance. However, OPH is recommending that younger children still follow a 10 day isolation and quarantine period because correct and consistent masking is difficult to maintain in this population.
- It is recommended that field trips and special events be altered or halted when COVID-19 transmission is high.
- Educate yourself, staff, and parents on [Multisystem Inflammatory Syndrome in Children \(MIS-C\)](#).

Please be reminded that PPE, such as KN95 masks can be purchased using LaCAP or ARPA funds. These masks are better than cloth masks for this variant. In addition, child care providers may use this funding to support staff in accessing COVID-19 vaccines, including paid time off for vaccine appointments and to manage side effects, as well as transportation costs to vaccine appointments.

NEW: Operation Expanded Testing

The U.S. Department of Health and Human Services (HHS) has established [Operation Expanded Testing](#) to provide fully funded COVID-19 PCR testing for K-12 schools, daycares, HBCUs, congregate settings, and underserved populations. Through an agreement with HHS and the Department of Defense (DOD), Eurofins Clinical Enterprise is able to offer no cost COVID-19 testing to states throughout the northeast and south regions as well as D.C., Puerto Rico, and the U.S. Virgin Islands. NEW: Bulletin 140 Waiver

On December 15, BESE approved a one-time waiver to Bulletin 140 required CLASS® observations for all publicly-funded early childhood classrooms. Classrooms that scored Proficient or higher during their Fall 2021 observation after third party replacement will be exempt from receiving a second observation from the community network lead agency in spring 2022. UPDATES FOR FUNDING AND ENROLLMENT

NEW: LA 4 and NSECD Payments

The Department is resuming an enrollment-based payment structure for LA 4 and NSECD for the period of January 1, 2022, through May 31, 2022. Attendance reports must be submitted by the 10th of each month. As the state continues to address the COVID-19 public health emergency, we will continue to evaluate the status of LA 4 and NSECD programs to ensure children in need are served. Due to funding constraints, school systems are not guaranteed payment for students enrolled in excess of their allocation.

NEW: SRTC Forms for Teachers and Directors

NEW: CCAP Family Redetermination Extensions

To ensure families continue to receive CCAP services, in light of the COVID-19 pandemic, redetermination cases have been extended for a three month period:

- January cases have been extended to April 30, 2022
- February cases have been extended to May 31, 2022
- March cases have been extended to June 30, 2022

REMINDER: Teacher Support Grant Round 2

To support the recruitment and retention of a qualified child care workforce, the Louisiana Department of Education is funding a second grant opportunity for open, center-based Type III early learning centers to provide financial support to child care teachers and staff. This grant will provide funding for open Type III early learning centers to provide financial support to child care lead teachers, assistant teachers, and support staff that are not center directors (e.g., bus drivers, cooks, custodians, front desk staff, etc.), in the form of stipends, bonuses, or wage supplements. Payment will be \$5,200 per eligible classroom.

Eligible classrooms are determined by the number of open classrooms in the EC (CLASS[®]) portal as of December 30, 2021. Apply by going to <https://form.jotform.com/213434757939064>.

If your center did not have classrooms open in the EC (CLASS) portal as of December 30, 2021, you are still encouraged to apply, please contact pheriche.perkins@la.gov if you have any difficulty submitting. Your lead agency will work with the Department to determine your number of classrooms that are eligible; however, this verification may delay your payment.

The application will open January 5, 2022, and the deadline for submitting the Teacher Support Grant is January 19 at 11 p.m. This grant opportunity is non-competitive, meaning that every eligible center that applies will receive funds. Providers should expect an audit after funds are spent. All providers should expect to provide the Department with documentation of the funds spent. This documentation could include records of stipends, bonuses, or wage supplements issued by staff members, check stubs of payments issued, documentation of how amounts were determined for staff, and bank records showing payments issued.

The Department anticipates that most payments will be issued in February 2022.

REMINDER: America Rescue Plan Act (ARPA) Stabilization Grant - Round 2

The Department is planning the final round of ARPA Stabilization Grants. The formula may be tweaked based on previous distribution of funds and in an effort to promote underserved populations. The base

amount will not be any less than the first round. The Department plans on releasing the grant application in mid-March 2022 with payments being released on a rolling basis beginning April 2022. Please note that for all grants, providers must keep receipts and documentation of expenditures for the items paid from these funds. Also, providers must complete audit documentation upon request even if the provider has closed.

REMINDER: Information on Timeframe and Uses of ARPA grants

The Department issued this [letter](#) in response to questions about the timeframe of use of the ARPA grants. Included in the letter is the list of allowable uses with additional details. Also, please be reminded that ARPA grant funds may not be used for construction or major renovations including land purchases.

NEW: Federal and State Taxes on LaCAP grants, ARPA grants, etc.

Grants provided through the stimulus funds (CARES, CRRSA, and ARPA) are subject to the same tax rules as regular CCDF funding. State tax rules apply. Regarding federal rules, please contact the Internal Revenue Service for guidance. In some cases, funds used to cover operating expenses may be exempt from taxation.

NEW: Annual CCAP Provider Forums Update

Out of an abundance of caution, the Child Care Assistance Program (CCAP) Provider Forums for providers and families will be conducted virtually due to the recent surge in COVID-19 cases. Virtual forums are slated to be conducted early spring 2022.

REMINDER: CCAP Underutilized Authorizations for Families and Paying on Enrollment

CCAP conducts a monthly review of underutilized authorizations of children who have not attended child care within the previous month. The Tracking of Time Services (TOTS) Point of Service (POS) and Interactive Voice Response (IVR) attendance records are examined as part of the underutilization review. If a CCAP child has not attended at least one day in the month, the family is pulled for underutilization review.

The Provider Help Desk staff has been informing providers of the importance of families completing check in/out transactions when children are in attendance to maintain CCAP certification. If CCAP children are not attending, the Department will contact families to assess the need for continued child care services. If families are not reached during this period, their CCAP authorizations will be discontinued at the end of the month, and they will need to reapply for CCAP.

As a reminder, CCAP payments are based on enrollment not daily attendance. **Again, the Tracking of Time Services (TOTS) Point of Service (POS) or Interactive Voice Response (IVR) must be used for CCAP children every day they are in attendance.**

UPDATES FOR LICENSED CENTERS, FAMILY CHILD CARE, AND IN-HOME PROVIDERS

REMINDER: Annual Required Inspections by the Office of State Fire Marshal, Louisiana

Department of Health, and City Fire of New Orleans.

Bulletin 137, Section 713, Renewal and Other Inspection Procedures, requires providers to obtain current approvals by the Louisiana Office of State Fire Marshal (OSFM), Louisiana Department of Health (LDH), and City Fire of New Orleans, if applicable, before the expiration of an existing license and the issuance of a renewed license.

Each provider must timely request and receive their annual inspections from the OSFM, LDH, and City Fire of New Orleans, if applicable.

Licenses will not be renewed if you have not received a current inspection and approval from those agencies and submitted documentation of their approvals to the Division of Licensing.

NEW: Critical Incidents and Required Notifications

The Department continues to note a significant number of deficiencies cited for failing to make critical incident notifications.

Providers must make immediate notification to parents, emergency personnel, law enforcement as applicable, and other appropriate agencies within 24 hours for the following types of critical incidents involving children in care:

1. death;
2. serious injury or illness that required medical attention;
3. a child left unsupervised for any amount of time;
4. use of prohibited behavior management as described in Section 1509.A.8.b.;
5. allegations or suspicion of child abuse or neglect by center staff;
6. an accident involving the transportation of children; or
7. any other significant event relating to the health, safety, or well-being of any child, including but not limited to a lost child, an emergency situation, fire or other structural damage, or closure of the center.

REMINDER: CPR/Pediatric First Aid (PFA) Vendors

The Louisiana Department of Education (LDOE) Division of Licensing is assisting licensed child care,

family home and in-home providers with obtaining Cardiopulmonary Resuscitation (CPR) and Pediatric First Aid (PFA) certification for early childhood staff. The LDOE approved CPR/PFA vendor will be authorized to be paid a rate up to \$65 per licensed child care staff member or registered and certified in-home provider. If a CPR/PFA vendor has not been approved by the LDOE and added to the LDOE Division of Licensing's roster, the CPR/PFA vendor will be unable to receive payment. Please note: under no circumstance can a vendor, who is a director or owner of a center, be paid for training the staff employed at their center.

Instructions to become eligible as a LDOE CPR/PFA vendor:

- Verify you are a registered vendor with the State of Louisiana and have a LaGov vendor number. (<https://wwwcfprd.doa.louisiana.gov/OSP/LaPAC/vendor/srchven2.cfm>)
- If not registered as a vendor, register prior to entering the LaGov PO. (Link to instructions: <https://www.doa.la.gov/media/gewlb4nk/lagov-vendorregistration.pdf>).
- Submit an Initial Proposal (quote) to the Louisiana Department of Education, Division of Licensing to Idelicensing@la.gov.
- The quote should include at a minimum the vendor number, a description of the training, the names of participants, and total dollar amount for training.
- Once the official quote is approved, a detailed statement will be required for each payment. The detailed statement should include:
 - Vendor Number
 - Description of the training
 - Names of the participants (Center Name, Address, Director's Name, and Phone Number)
 - Invoice Number
 - Quantity for the training (number of individuals to whom this vendor will be providing services. Up to 300 center staff can be trained at a rate of up to \$65 per staff).
 - Total dollar amount
 - Accepted method of payment (P-card payment-credit card or check)
- Ensure you are able to provide a live demonstration and receive a live demonstration from the early childhood center staff.
- Certification documentation will need to be submitted.

REMINDER: Child Care Management Software Initiative (CCMSi)

The Child Care Management Software (CCMS) Initiative has now launched! If Type III and CCAP-eligible family child care providers purchase a new subscription to an approved CCMS identified in the LDOE

[CCMS Guidebook](#), they are eligible for a reimbursement of up to 80% (for a maximum reimbursement of \$1,000). CCMS purchases are made directly from the provider to the vendor and reimbursements are processed through the local [CCR&R](#). This funding is only available for **NEW** CCMS annual subscriptions.

To support this launch and future initiatives, the Department asks that providers of all license types (I, II, III and FCC's) fill out this [short survey](#) regarding CCMS so we can better understand CCMS usage throughout the state.

REMINDER: Tax Consultation

Child care providers have experienced changing finances that directly impact their taxes. The LDOE has contracted with tax professionals to provide support services to licensed early learning providers. These early childhood-trained tax professionals will provide up to two hours of tax consultation to a limited number of early learning providers of all license types (I, II, III and FCC's).

Consultation can help you:

- Understand how loans and grants have impacted or can impact your taxes
- Use or understand payroll systems and bookkeeping software such as QuickBooks
- Proactively prepare for the upcoming tax season
- Handle or develop a plan to handle any tax concerns or questions you might have
