Purpose and Main Features of the Rule: The purpose of this rule is to establish a uniform reporting requirement for local filing officers to utilize so that they may report violations of the Georgia Government Transparency and Campaign Finance Act ("Act") to the Georgia Government Transparency and Campaign Finance Commission. Thus, facilitating the Georgia Government Transparency and Campaign Finance Commission ability to enforce the Act and collect monies due and owing to the State.

189-7-.03 Notice of Late Filings and Outstanding Late Fees By Local Filing Entities.

At the end of each month each local filing officer shall electronically report to the Commission, in a format consistent with the directions of Commission staff, the name, address, filer identification number (if known), governmental office held (if any), filing type, due date, and actual filing date (if any) for each and every filing from each and every filer required to file with the local filing officer but which filing has not been timely submitted to the filing officer.
