

# **Legislative Communications Tools**

Below is a list of various ACCG communications tools that will help keep county officials informed and engaged during the legislative session.

## **Weekly Legislative Update:**

- Distributed every Friday afternoon during the legislative session via email. The first issue of the 2021 Legislative Update will be distributed on Friday, January 15. If you do not receive the update, please email Schuyler Harding (<a href="mailto:sharding@accg.org">sharding@accg.org</a>) to be added to the mailing list.
- In the Legislative Update, bills are categorized as such:
  - What's New new bills that have been introduced. You will not see these again unless they begin moving through the legislative process
  - o Progressing bills that are moving through the process and deserve your attention
  - Immediate Action Needed bills that are at a critical stage in the process and immediate action is needed
- Bills are assigned one of the following ACCG positions:
  - Support
  - o Oppose
  - Neutral impacts counties but ACCG is not advocating for or against the issue
  - Negotiating author of the bill has expressed a desire to work with ACCG to address our concerns
  - Evaluating ACCG is researching the issue(s) to determine if it has an impact on counties and to what degree
  - Each bill has one ACCG lobbyist assigned to it as the point of contact. Feel free to contact them directly.
