SUBJECT: Covid-19 Testing Requirements

As we are all aware, the COVID 19 pandemic and the need to Re-Open Connecticut is our top priority. The need to increase testing across the state plays a major role in the endeavor.

At this time, the Department of Public Health (DPH) is requiring the use of nucleic acid COVID-19 testing for staff in Nursing Home Facilities, Managed Residential Communities, and Assisted Living Services Agencies as required under Executive Order No. 7AAA. COVID-19 testing by an antigen test (ie. Quidel Sofia) or antibody testing is not appropriate for the above populations and would be considered noncompliant with the Executive Order.

DPH is also not recommending the antigen test for testing of individuals in congregate living settings or other high-risk populations. Antigen testing is known to have a lower sensitivity than nucleic acid testing and a negative antigen result needs to be treated as presumptive negative. FDA states that negative results from antigen testing should be confirmed with an FDA-authorized molecular assay, if necessary, for patient management.
