RE: Distribution of Personal Protective Equipment (PPE)

The Connecticut Department of Public Health (DPH) will be providing personal protective equipment (PPE) to Home Health Care and Hospice providers beginning Monday June 8, 2020.

The points of distribution will be operated by the DPH in collaboration with the military department.

Home Health Care and Hospice providers must pick up their supplies at these locations on a weekly basis. Each provider located within the corresponding geographic planning region, should send one representative for their PPE package. Each representative should bring a form of identification that documents the facility they are picking up the PPE for. Do not arrive at a regional point of dispensing site if your facility is not located within that region.

The points of distribution will be open from 9AM-3PM on the following days:

- Region 1-Mondays: Sherwood Island State Park, Sherwood Island Connector, Westport, CT
- Region 2-Tuesdays: North Haven Recreation Center, 7 Linsley St., North Haven, CT
- Region 3-Wednesdays: 25 Brixton Street, West Hartford, CT
- Region 4-Thursday: Thames Garage, Mohegan Sun, Uncasville, CT
- Region 5-Fridays: Bethlehem Fairgrounds, 384 Main St. North, Bethlehem, CT
