



Canadian Recreational Vehicle Association Wholesale Shipment Report into Canada for the 2nd Quarter and YTD Ending June 30th, 2025



Summary

The Canadian Recreational Vehicle Association (CRVA) reports that RV wholesale shipments into Canada for the 2nd Quarter ending June 30th, 2025, totaled **7,867 units**, representing a **14.7% decrease** over the **9,221 units** shipped during the same period in 2024.

According to Statistical Surveys, as reported by the RVDA of Canada, retail activity during the quarter totaled 13,129 units. The gap between shipments and sales reflects a significant draw down of dealer inventories, particularly in motorized product during the quarter

RV Wholesale Shipments into Canada YTD as of June 30th totaled **17,852 units** vs **17,307** in 2024, representing a slight increase of 3.2% year over year overall.

This pullback was largely anticipated. In the first quarter, many Canadian RV dealers accelerated orders to get ahead of proposed countermeasure tariffs announced by the federal government, which boosted Q1 wholesale activity.

Canada's counter-tariffs on motor homes, in place from April through June, affected motorized shipments, leading to sharper year-over-year declines in that segment.

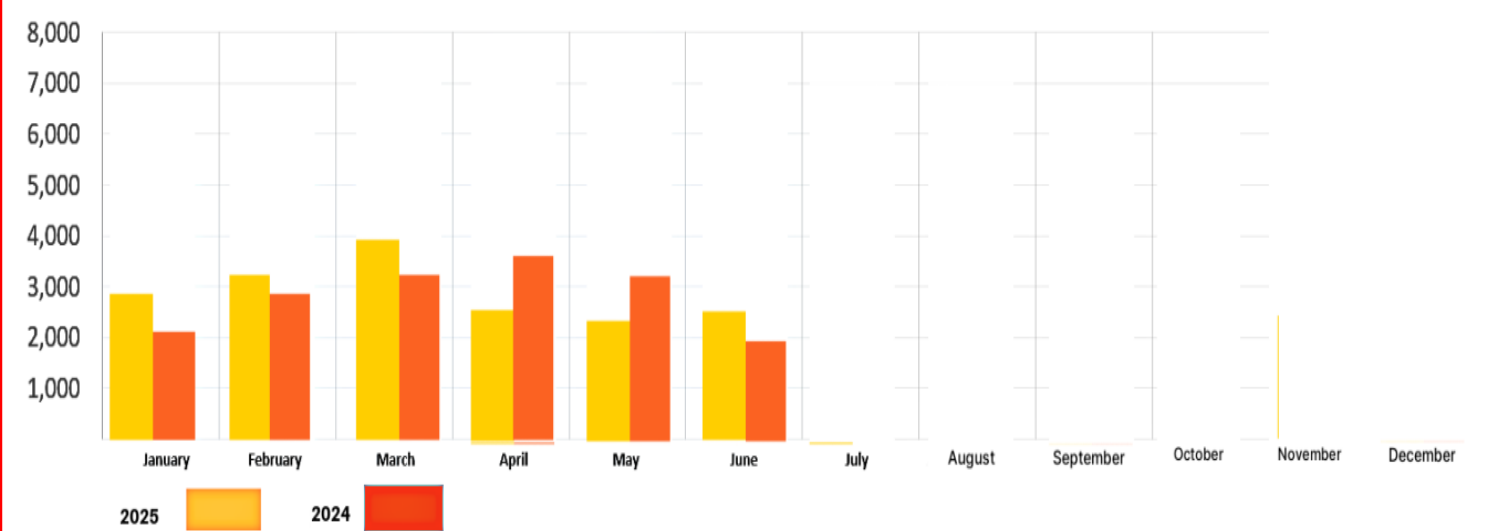
CRVA has strongly advocated the importance of a tariff-free and fair RV trade environment across North America for all members. The current tariff policies by the US Administration has created uncertainty and highly unfair disadvantages for Canadian manufacturers exporting goods into the United States. Canada has eliminated all tariffs on Recreational Vehicles shipped from the US.

We will continue to work with government and industry partners on both sides of the border to ensure that trade returns to balanced and reciprocal, supporting manufacturers, dealers, and consumers in Canada and the United States alike.

RV Type Definitions

Definition

Recreational vehicle (RV), A vehicle or slide-in camper that is designed to provide temporary living, sleeping, or eating accommodation for travel, vacation, seasonal camping, or recreational use and designed to be driven, towed, transported, or relocated from time to time whether or not the vehicle is jacked up or its running gear is removed, and with a size as defined by CSA Z240 RV Series Recreational Vehicles, published by the Canadian Standards Association (CSA).

Travel Trailer, A Recreational Vehicle mounted on wheels and designed to be towed by a motorized vehicle that is constructed with a roof and sidewalls made of rigid materials and which are manufactured to the CSA Z240 RV series or NFPA 1192 standard.



Fifth-wheel trailer, A Recreational Vehicle mounted on wheels and designed to be towed by a motorized vehicle by means of a towing mechanism that is mounted above or forward of the tow vehicle's rear axle and which is manufactured to the CSA Z240 RV series or NFPA 1192 standard.



Motor home, A Recreational Vehicle that is selfpropelled which includes vehicles described as "Class A", "Class B" and "Class C" and which are manufactured to the CSA Z240 RV series or NFPA 1192 standard.



Folding Camping Trailer, A Recreational Vehicle mounted on wheels and designed to be towed by a motorized vehicle that is constructed with a collapsible roof and collapsible partial sidewalls that unfold and extend in the set-up mode and fold back up for travel and which are manufactured to the CSA Z240 RV series or NFPA 1192 standard.



Truck camper, A Recreational Vehicle designed to be loaded on and unloaded from the bed of a pickup truck and manufactured to the CSA Z240 RV series or NFPA 1192 standard.
