##### **Kim White | Survivor, Advocate, Case Manager | Sexual Assault Counseling & Information Service (SACIS)**

Kim (she/her/hers) began her career with SACIS in 2019 as a volunteer on Team SACIS, moved forward a year later to become a part time medical advocate, and transitioned further to a full time Advocate/Case Manager/Legal Advocate position. You will find Kim advocating throughout our community from the legal system, hospitals, correctional system, and supporting our clients through community resources. Before joining SACIS, she was a decorated Correctional LPN for many county jails in Indianapolis and surrounding counties as well as Plainfield Correctional Facility. Kim is also a Veteran of the U.S. Army where she served as a Combat Medic. Kim is a Human Sex Trafficking survivor from familial trafficking to adult human trafficking and is extremely passionate about telling her story to spread awareness and educate on Human Trafficking. It is her mission to help connect the dots on a very complex and layered crime happening among us, with the ultimate goal of giving victims of Human Trafficking the well-deserved care from every level of our community.
