COUNTRY MUSIC ASSOCIATION (CMA) FOUNDATION SCHOLARSHIP

Donor: This scholarship is provided to the Tennessee Arts Academy Foundation through the generosity of the Country Music Foundation (CMA) Foundation and will be annually awarded to numerous music teachers to attend the upcoming TAA Summer Institute on the Middle Tennessee State University campus in Murfreesboro, TN (or virtually if the need arises).

Eligibility: CMA Foundation scholarship funding will be awarded to full-time K-12 music educators. Consideration will be given to all applicants. Special consideration will be given to applicants who 1) are first time Summer Institute attendees; and 2) can show need. The committee values those applicants who are able to provide some funding support on their own — from their school or school system and/or from other sources (PTA/PTO, local businesses/banks, community/civic groups, etc.) — in order to help stretch the available scholarship funds; however, matching money is not a requirement of this scholarship. All requests, from supplemental assistance to a full scholarship, will be given equal consideration.

Number of Scholarships Available: The scholarship fund currently has \$2,500 available. Numerous scholarships will be awarded until the fund is depleted.

Scholarship Benefits: Scholarships vary and may include partial TAA Summer Institute tuition, full TAA Summer Institute tuition (\$489), and/or on-campus housing costs (up to \$149).

Award Period Information: The eligibility period for scholarship submission ends on May 1 or until funds are depleted. A committee will choose the recipients and will base their decision on the scholarship application materials, merit and need. The scholarship shall be awarded no later than June 1st.

Eligibility: In order to be eligible for the Theatrical Rights Worldwide (TRW) Scholarship, candidates:

- Must be a Theatre Arts teacher and/or Theatre Director in a public, private or charter school (K-12th).
- Must confirm you plan to teach theatre in a public, private or charter school (K-12th) setting the year commencing the TAA Summer Institute.
- Must submit a 100-word essay describing how attending the TAA Summer Institute will benefit your musical theatre program at your school.
- May submit awards and/or honors received to date.

Number of Scholarships Available: One Full Tuition Scholarship and On-Campus Housing (as needed)

Scholarship Benefits: Full TAA Summer Institute tuition (\$489). For those who live outside of the Greater Murfreesboro area, the scholarship will also include on-campus housing if needed.

DOROTHY M. GILLESPIE TENNESSEE ARTS ACADEMY VISUAL ART SCHOLARSHIP

Donor Information: This scholarship is provided to the Tennessee Arts Academy Foundation through the generosity of the Dorothy M. Gillespie Foundation and will be annually awarded to one female visual art teacher to attend the upcoming TAA Summer Institute on the Middle Tennessee State University campus in Murfreesboro, Tennessee (or virtually if the need arises).

Eligibility: In order to be eligible for the Dorothy M. Gillespie Tennessee Arts Academy Visual Art Scholarship candidates must:

- Be a female, visual art teacher in a public, private, or charter school (K-12)
- Have no more than 5 years teaching experience
- Be a first time TAA Summer Institute attendee
- Plan to teach visual art in a public, private, or charter school for the 2025-2026 school year

Number of Scholarships Available: Minimum of One (more if funds are available)

Scholarship Benefits: Full TAA Summer Institute tuition (\$489). For those winners who live outside of the Greater Murfreesboro area, the scholarship will also include (as needed): on-campus semi-private housing, travel money, and a \$150 stipend to cover those meals not provided during the TAA Summer Institute week.

Award Period Information: The eligibility period for scholarship submission ends on March 21. A committee will choose the recipient and will base their decision on the scholarship application materials, merit and need. The scholarship shall be awarded no later than April 7.

About Dorothy M. Gillespie: Dorothy M. Gillespie (1920–2012) was an American painter and sculptor who enjoyed an artistic career spanning more than seventy years. Born in Roanoke, Virginia, Gillespie studied at the Maryland Institute College of Art and the Art Students League in New York City. During her lifetime, she created, exhibited, and sold her artwork nationally and internationally. Early in her career and during her time in New York City, Gillespie contributed to the women’s art movement through her work. Gillespie was well known as a painter, sculptor, and installation artist. Her work encompassed many significant twentieth-century trends in art, including abstract expressionism, decorative abstraction, site-specific installations, the women’s movement, and art in public spaces. She pioneered joyful new directions for metal sculpture and is best known for her large-scale, colorfully painted arrangements of cut aluminum strips that radiate, undulate, or curl like giant arrangements of ribbon, enchanted towers, or bursting fireworks. Her work can be found all over the country in both public and private spaces. In 1997, Gillespie was a celebrity muser at the TAA Summer Institute. In 2017, a retrospective exhibition of her work was mounted and displayed during the TAA Summer Institute in Belmont’s Leu Art Gallery.
