

# Executive Certificate in Healthcare Management & Leadership

## Course Overview-Fall 2026

### Course Overview

The Executive Certificate in Healthcare Management & Leadership equips healthcare professionals—including current leaders, rural health professionals, and emerging talent—with skills in leadership, strategic management, financial acumen, and performance improvement. Delivered in a hybrid format (in-person, synchronous, and self-paced), the program prepares participants to lead effectively, drive innovation, and improve healthcare operations. It concludes with a Service Line Competition, where participants present a healthcare service solution to industry leaders.

### Target Audience

Ideal for emerging and mid-level professionals, including administrators, clinical leaders, and those transitioning into management. Especially valuable for professionals in rural or underserved settings, including those working in rural hospitals, critical access facilities, tribal health systems, public health departments, and other rural-serving organizations, as well as corporate healthcare or consulting roles.

### Program Commitment & Disclosure

The **Executive Certificate in Healthcare Management & Leadership Program** requires full participation in all program components, including:

- **Three in-person Houston-based sessions** (September 18, October 16, and November 13), **with Zoom participation** available for the October 16th session.
- **Rural and international participants may complete the program entirely in a hybrid format**, ensuring accessibility regardless of location.
- **Completion of all modules and submission of program feedback**
- **Participation in the final Service Line Competition**

Participants will receive an Executive Professional Certificate and a LinkedIn Certificate as part of the core program.

### Program Fee

The program fee is **\$4,500**, including all instructional content, live sessions, and modules. Early bird rate: \$3,950 (apply by August 21, 2026). Reduced rates available for rural health professionals. **Continuing Education (CME/CNE)**: Optional credits available at an additional cost based on credits claimed—contact us for current rates and details.

Applicants must commit to attending both Friday in-person sessions without conflicts from professional obligations. A bachelor's degree and 3–5 years of healthcare experience are required (exceptions considered).
