**Important Updates:** This reflects an update to our 7/13/2020 Underwriting Update Bulletin ([link](#)).

Due to the evolving impact of COVID-19, we are pleased to announce the following updates to our temporary underwriting guidelines, effective 4/30/21. We will continue to monitor the situation, reevaluate as needed, and communicate regularly.

#### Revised Age Limits:

We are currently able to extend offers to the following applicants:

- Ages 65 and below for all ratings through Table H
- Ages 66–70 all ratings through Table D
- Ages 71-80 at Standard or better risk classes

#### Additional COVID Guidelines:

- For applicants who have previously tested positive for COVID-19, we will no longer require a doctor's letter unless applicant has required ongoing care or hospitalization. However, we do require a Certificate of Health or Statement of Good Health.
