FUNDRAISING OPPORTUNITIES 2023-2024

The Home and School Association offers several ways for families to meet their fundraising obligation of \$440.00. Listed below are the tentative fundraisers planned for the 2023-2024 academic year.

Mums Fundraiser: \$2.00 from every mum sold will be applied to your fundraising balance. For example, if you sell ten mums for \$67.50, \$20.00 will be deducted from your \$440.00 HSA balance. Orders are due on Friday, September 13, 2023 and order pick-up at CCS will be held on Wednesday, September 27, 2023 from 1:30 p.m. – 4:00 p.m.

Cherrydale Farms: 40% of your total sales will be applied to your fundraising balance. For example, if you sell \$100.00 worth of products, \$40.00 will be deducted from your \$440.00 HSA balance. This fundraiser will begin on Wednesday, September 13, 2023 and orders are due on Wednesday, September 27, 2023.

MCM Lyman Orchards Pie / Cookie Fundraiser: 40% of your total sales will be applied to your fundraising balance. For example, if you sell \$100.00 worth of products, \$40.00 will be deducted from your \$440.00 HSA balance. This fundraiser will begin on Monday, October 2, 2023 and orders are due on Monday, October 16, 2023. Pies and cookies order pick-up at CCS will be held on Wednesday, November 15, 2023 from 1:30 p.m. - 5:00.

Walk-a-thon: 100% of your total donation will be applied to your fundraising balance. For example, if you raise \$100.00 for the walk-a-thon, \$100.00 will be deducted from your \$440.00 HSA balance. Walk-a-thon is scheduled for Thursday, October 21, 2023 and the rain date is Friday, October 22, 2023.

Christmas Wreaths: 20% of your total sales will be applied to your fundraising balance. For example, if you sell \$100.00 worth of wreaths, \$20.00 will be deducted from your \$440.00 HSA balance. This fundraiser is scheduled to begin on Monday, November 6, 2023 and orders are due Monday, November 20, 2023. Wreath order pick-up at CCS will be held the week of November 27, 2023.

Munson's Chocolates: 25% of your total sales will be applied to your fundraising balance. For example, if you sell \$100.00 worth of products, \$25.00 will be deducted from your \$440.00 HSA balance. This fundraiser is scheduled to begin on Monday, February 5, 2024 and orders are due Monday, February 19, 2024. Munson's Chocolates order pick-up at CCS will be held the week of November 27, 2023.

Cherrydale Farms: 40% of your total sales will be applied to your fundraising balance. For example, if you sell \$100.00 worth of products, \$40.00 will be deducted from your

\$440.00 HSA balance. This fundraiser will begin on Monday, March 11, 2024 and orders are due on Monday, March 25, 2024.

Double Good Popcorn: 40% of your total sales will be applied to your fundraising balance. For example, if you sell \$100.00 worth of products, \$40.00 will be deducted from your \$440.00 HSA balance. This fundraiser is scheduled to begin on Monday, April 15, 2024 and orders are due on Monday, April 29, 2023.

Golf Tournament: 50% of your sponsorship or advertising amount (capped at \$440.00) will be deducted from your \$440.00 HSA balance. For example, if you sponsor a tee for \$175.00, \$87.50 will be deducted from your \$440.00 HSA balance. Ticket purchases do not count towards your HSA balance.
