If your family received tuition assistance for the school year, the amount applied will be prorated depending upon the amount of time your child(ren) attended school prior to their withdrawal. If a refund is due after withdrawal, Corpus Christi School will send that refund within 30 days.

Parish Affiliation: Parent is responsible for submitting a signed Parish Affiliation form. To receive the Catholic Parishioner rate a signed Parish Affiliation form must be submitted to the school office. The form can be found on the Corpus Christi School website under Admissions heading.

TUITION PAYMENT OBLIGATIONS

- **ALL** families are required to have an active FACTS account handled by FACTS Tuition Management

- The Payment plans available on FACTS are:
 - (A) Full payment due by July 1st, 2026 or
 - (B) (10) installments (July 2026 - April 2027) with an option of the 1st or 15th for withdrawal each month thru a bank account or credit card **ONLY**
- **PLEASE NOTE: CCS will no longer be accepting direct payments.**
- If you are a returning family, once you have submitted all your registration materials, your tuition will be entered into your FACTS account. You will receive a notification from FACTS, via the email you provided, with instructions to log into your existing account and make any changes needed to your financial information or number of payments. **IF YOU DO NOT RESPOND** to this notification, the financial information and number of payments from the previous school year will automatically be used to finalize your account for the next school year. CCS will no longer be using invoicing for payment so families must go thru their bank account or a credit card.
- All Scholarships and financial aid will be applied where applicable

Payments begin July 1st, 2026.

- Eighth grade students whose tuition obligations are not satisfied in full will not be permitted to participate in the Eighth Grade Graduation Activities.
- Admission for the school year will be denied if tuition payments are not current prior to the start of school.
- Students will need to remain current with tuition payments; failure to remain current can and will result in the removal of your child(ren) from Corpus Christi School.
- Students will not be allowed to begin the second half of the school year in January if tuition payments are not current at the time.
- It is each family's responsibility to keep FACTS Tuition Management updated should changes be necessary in personal billing information. This includes mailing, banking, change of email, change of phone number and any other information.
- Information will be provided to you by FACTS regarding instances of insufficient funds and fees incurred, as these are FACTS' fees and must be paid to them.
- **NO family is excused from their tuition obligation due to extended vacations.**
- **Tuition owed must be paid on time and in full.**
