## The Integrity Certified Behavioral Health Clinic

For individuals experiencing substance use disorders and mental health conditions, finding care can often feel like navigating a maze of disconnected programs. Fragmented systems result in gaps in care, consumer frustration, and sometimes, disengagement from services altogether. A model for integrated care, the Integrity Certified Community Behavioral Health Clinic (CCBHC) is intentionally designed to mitigate those challenges and make access to care more seamless.

Established in 2020, the Integrity CCBHC provides same-day access to outpatient mental health services, addiction treatment, physical health care, crisis services, and care coordination, all within a single facility.

The Integrity CCBHC serves hundreds of individuals each year. In 2024, the clinic served over 1,300 individuals reflecting a 17% increase from 2023.

In recognition of his generous support and 15 years of dedicated service as an Integrity House Trustee, Integrity House is proud to honor **Joseph A. Hayden, Jr.** as an *Integrity House Champion*.

For more than five decades, Joe Hayden has stood among New Jersey's most respected attorneys, known for his unwavering professionalism, ethical leadership, and exceptional skill in the courtroom. A graduate of Rutgers Law School, Joe began his career as a law clerk to the Chief Justice of the New Jersey Supreme Court, followed by his appointment as Deputy Attorney General in the Division of Criminal Justice, where he tried the first wiretap case in New Jersey's history.

As founder and first president of the Association of Criminal Defense Lawyers of New Jersey (ACDLNJ), Joe helped shape the state's criminal defense bar and elevate standards of practice. His excellence has been recognized with some of the profession's most prestigious honors, including the Justice William J. Brennan Award from the Association of the Federal Bar of New Jersey, the Daniel J. O'Hern Award for Professionalism, the Lawrence A. Whipple Award for Professional Excellence, and the Rutgers Law Distinguished Alumnus Award. His insights and expertise have also made him a trusted legal commentator and lecturer nationwide.

Beyond the courtroom, Joe has never lost sight of the human side of justice. He has been a steadfast champion for individuals battling substance use disorders, using his compassion and experience to provide individuals with recovery support that may help them attain lasting recovery and stability.

His public service extends far beyond his legal career. Joe serves as a trustee of the New Jersey Reentry Services Commission, supporting formerly incarcerated individuals as they rebuild their lives. A veteran of the civil rights movement, he participated in the historic Selma to Montgomery march in 1965, an early testament to his lifelong commitment to justice and equality.

Integrity House is proud to honor **George Helmy** with the *Excellence in Community Leadership* award in recognition of his leadership and tireless advocacy in advancing integrated behavioral health care.

Over the course of his remarkable career, George has served the people of New Jersey with vision, integrity, and dedication. He began his career as an aide to the late U.S. Senator Frank Lautenberg, working on issues such as gun safety and financial affairs. George went on to serve as State Director to U.S. Senator Cory Booker, overseeing all New Jersey operations.

From 2019 to 2023, as Chief of Staff to Governor Murphy, George helped oversee all aspects of state government, managing the day-to-day operations of the Governor's Office and Executive Branch. He played a central role in advancing the Governor's major policy initiatives, legislative agenda, communications strategy, and crisis response, including leading the state's response to the COVID-19 pandemic. His steady leadership during those challenging years earned him recognition as the longest-serving gubernatorial Chief of Staff in New Jersey history.

From September through December 2024, he served as a United States Senator, appointed by Governor Phil Murphy to fill a vacancy, continuing a legacy of public service that has defined his professional life.

Today, George continues his service on several influential boards, including the Port Authority of New York and New Jersey, where he chairs the Governance and Ethics Committee; the Rutgers University Board of Governors, where he chairs the Finance and Facilities Committee; and the Regional Planning Association and Elijah's Promise. His leadership has twice been recognized through unanimous confirmation by the New Jersey Senate.

Following his clerkship, he served as a partner at Chasan Leyner & Lamparello, PC, where he focused on civil rights, criminal and governmental litigation, commercial and municipal law, and employment and corporate matters in both state and federal courts.

Judge Neals has devoted his career to public service, holding pivotal leadership roles in Newark and Bergen County. As Chief Judge of the Newark Municipal Court, he introduced innovative programs to improve court efficiency and access to justice. As Corporation Counsel and later Business Administrator for the City of Newark, he oversaw municipal operations, budgeting, and the day-to-day management of multiple city departments, consistently emphasizing equity, fairness, and community engagement. From 2015 to 2021, he served as County Counsel and Acting County Administrator for Bergen County, further demonstrating his commitment to responsible, transparent governance.

In 2021, Judge Neals was sworn in as a United States District Judge for the District of New Jersey, where he continues to exemplify the highest standards of judicial excellence, integrity, and public service.

Throughout his career, Judge Neals has remained deeply committed to Newark — its people, its institutions, and its potential. His work reflects a steadfast belief in justice, equity, and community, principles that resonate with Integrity House's mission to empower individuals overcoming substance use disorders and mental health challenges.


## About Us

**Integrity House** is New Jersey's longest-standing provider of comprehensive substance use disorder (SUD) services. Since our founding in 1968, our goal has remained constant - to provide comprehensive, whole-person care options under one unified system of care. Operating programs in Kearny, Morris Plains, Newark, Paramus, Secaucus, and Toms River, we serve over 3,000 individuals through our clinical programs every year and thousands more through our community outreach and prevention programs.

Integrity House operates a broad network of clinical programs and community-based interventions. We offer a full continuum of care for SUD that includes intensive inpatient residential services, high-intensity residential services, low-intensity residential services, partial care, intensive outpatient services, and outpatient services. Integrity House is also equipped to facilitate rapid access to withdrawal management services through its role as a third-party operator of addiction services.

Designed to offer additional pathways to healing, our community outreach and recovery programs range from a mobile treatment clinic and harm reduction center, to supportive housing and the Crisis to Community Initiative, designed to help individuals experiencing symptoms of serious mental illness in local emergency departments quickly connect to community-based care.

Our care team includes board-certified medical doctors, alcohol and drug counselors, social workers, professional counselors, nurses, peer recovery specialists, and more, all committed to helping those who come to us for help access deep healing, care, and recovery.






