Dolphin/Wahoo Weigh-In: 3pm - 4pm @ Hawks Cay Marina, M.M. #61

1. The following species of fish and minimum weights will be accepted for point:

DOLPHIN 10 lb. minimum

12 fish maximum per boat

WAHOO 5 lb. minimum

12 fish maximum per boat

<u>Points to be awarded as follows</u>: (1) point per pound- Five (5) additional bonus points awarded for each eligible <u>Wahoo</u> weighed. (No mutilated, gutted, or "pre-cleaned" fish will be eligible. Whole fish only will be weighed for points.) Tag your fish!

All boats entered that are owned and operated by amateur captains (non-professionals) shall be awarded an additional 5 bonus points to total score of fish weighed. If no eligible fish are entered, no bonus points will be awarded.

- 2. Only fish caught by <u>registered anglers</u> will be entered in this Tournament. Contestants are bound by ICFA angling rules.
- 3. Boats may be launched from any port in Monroe, Dade, Broward or Palm Beach counties. To be eligible, all fish MUST be brought to the ECA weigh station at Hawk's Cay Marina. Fish may be brought by boat or automobile to the marina. If arriving by automobile, you MUST be in view of the weigh- master by 4:00 p.m. sharp. No exceptions.
- 4. Lines in the water any time after 6:00 a.m. Weigh in will be from 3pm to 4pm. <u>Fish must be on the dock or in line **and visible** to the weigh-master, or seen by the spotter boat no later than 4pm sharp to be eligible. Time of weigh-in will be used as a tiebreaker.</u>
- 5. Maximum of 6 anglers per boat / Maximum line size of 50-lb test, no wire lines will be allowed.
- 6. If NOAA forecast for the Islamorada area calls for a small craft advisory, the decision is under the CAPTAIN's discretion. NO REFUNDS
- 7. <u>INDEMNIFICATION, DEFENSE AND HOLD HARMLESS</u> It is expressly understood that all participants in the Tournament enter at their own risk and agree to defend, indemnify and hold harmless the Engineering Contractors Association of South Florida, Inc., its officers, directors and all persons connected with the operation of the Tournament from any liability or loss, damage, negligence, harm or injury suffered by any participant which may occur during the Tournament.
 - All boat owners and renters, as well as the captains, are responsible for all riders on their Tournament boats and responsible for providing these Rules to all riders on the boats before leaving the dock on the day of the Tournament.
- 8. Tournament Channel is _____ (To be determined at Captain's Meeting)
- 9. Captain's Meeting is mandatory on the Friday evening before the Tournament.
