REGISTRATION:

PLACEMENT:

All Bee and Butterfly students placed for the 2025-2026 school year will be invited to enroll with placement made on a first come, first served basis. If spots remain open in the class, we will then promote the program to the broader Pines church and preschool family via word of mouth and school emails/newsletters.

FEES:

\$25.00 Application Fee + \$50.00 Tuition Deposit = \$75.00 due at the time of placement into the class.

NON-REFUNDABLE AND CANNOT BE APPLIED TO ANY OTHER CHILD OR PINES PROGRAM.

\$100 Remaining Tuition (also non-refundable) is due by second class, Monday, March 31, 2025.

Waitlisted families will be contacted via phone/email as spots become available through April 7. They will not be charged the application fee or tuition deposit until placement and tuition will be pro-rated at \$25/week if placed after class begins.
