

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to NevBio.org, and the Nevada Biotechnology & Health Science Consortium and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Nevada Biotechnology & Health Sciences Consortium include NevBio, and NevBio.org. By using the NevBio newsletter and/or website, you consent to the data practices described in this statement.

Collection of your Personal Information

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include (a) registering for an account; (b) sending us an email message. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather personal information or non-personal information in the future.

Use of your Personal Information

NevBio collects and uses your personal information to operate and deliver the services you have requested.

NevBio may also use your personally identifiable information to inform you of other products or services available from NevBio and its affiliates.

Sharing Information with Third Parties

NevBio does not sell, rent, or lease its customer lists to third parties.

NevBio may share data with trusted partners to help perform statistical analysis, send you emails, or provide customer support. All such third parties are prohibited from using your personal information except to provide these services to NevBio, and they are required to maintain the confidentiality of your information.

NevBio may disclose your personal information, without notice, if required to do so by law or in the good faith that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on NevBio or the site; (b) protect and defend the rights or property of NevBio; and/or (c) act under exigent circumstances to protect the personal safety of users of NevBio, or the public.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by NevBio. This information can include: your IP address, browser type, domain names, access times, and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the NevBio website.

Use of Cookies

The NevBio website may use "cookies" to help personalize your online experience. A cookie is a text file that is placed on your computer by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

SSL protocol

We strive to take appropriate security measures to protect against unauthorized access to or alteration of your personal information. Right to Deletion

Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;

Comply with an existing legal obligation; or

Otherwise, use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Under Thirteen
