# THE CHILDREN'S LEAGUE OF MASSACHUSETTS



Dear Valued Member,

Thank you for being a member of the Children's League of Massachusetts! Your partnership, expertise, and commitment continue to be the driving force behind CLM's advocacy. Your participation in the League means CLM ensures our members' voices, successes, and challenges are heard and addressed in the Legislature and with the Administration; and keeps a spotlight on important long-term topics in child welfare.

#### Together our League:

- Secured additional enhancement funding from economic development and pandemic relief dollars to support workforce recruitment and retention.
- Passed the Foster Parents' Bill of Rights, ended child marriage in Massachusetts, closed a loophole preventing some adoptees from accessing their original birth certificate, and advanced other critical pieces of CLM's priority legislation through Committees and closer to final passage.
- Secured increases to state investments in Chapter 257 rates, Family Support and Stabilization, Family Resource Centers, Child and Adolescent Mental Health Services, the Center on Childhood Trauma and Wellbeing, and other line items that support the health, safety, and well-being of children, youth, and families.
- Amplified members' voices and perspectives to the incoming Healey Administration, with Legislative leaders who oversee our issues, and in important state-led commissions including the Juvenile Justice and Policy Data Board, Child Trauma Task Force, Children's Behavioral Health Advisory Council, the Families and Children Requiring Assistance Advisory Board, and other formal and informal agency conversations.
- Brought state and national leaders into conversation with our members at our monthly member meetings and other convenings.

Renewing your organization's membership for FY2024 will be critical for building on that momentum.



Over the next year, CLM will continue working to position children, youth, families, and the human services workforce as top-level priorities for Governor Maura Healey and her Administration. We are already deep into a new legislative session with many issues from our sector on the table, including documenting and confronting disproportionality in child welfare, proposed reforms to the system of helping Children Requiring Assistance, lifting kids and families out of deep poverty, and other issues that directly affect providers, youth, and families.

**Our goals remain clear:** to ensure families have the tools they need to thrive; that the child welfare system operates as efficiently and effectively as possible to keep kids safe and healthy; and that the state lives up to its responsibilities to the children, youth, and families it brings into the system.

CLM will invoice your organization for your dues once the form is received and reviewed. # WHO WE ARE

## **Our League**

The Children's League is a statewide non-profit that leads the charge on expanding the availability, accessibility, and quality of children's services in Massachusetts. Our league is comprised of nearly 60 organizations that provide direct services, advocacy, and education benefiting children, youth, and families.

## **Our Work**

We advocate for supports and services that will ensure all children and youth have access to safety, permanency, and wellbeing.

#### CLM serves as:

- A forum for the exchange of information and ideas among members;
- A vehicle for keeping the focus on the needs of children, youth and their families;
- · A powerful source for common action.

## **Our Issues**

CLM focuses on a wide variety of issues, primarily centered on the child welfare system but connecting to issues that affect vulnerable children, youth, and families, as well as community-based providers of services.

#### These include:

- Promoting safety and well-being for children and youth;
- Providing a continuum of supports and services for families;
- Supporting permanency and stability for youth in the foster care system;
- Strengthening access to health care, including mental and behavioral health care, for vulnerable youth;
- Improving education outcomes for children in foster care;
- Ensuring success for youth aging out of state care without permanency;
- Maintaining a stable, robust, and valued children's service workforce;
- Addressing elements of poverty that destabilize families, including affordable housing, nutrition, and childcare;
- Addressing intersectional issues that impact child welfare, such as juvenile justice, disproportionality, and racial and LGBTQ equity.



# **CLM'S APPROACH**

## **Our Focus**

As a membership association, the Children's League leads advocacy efforts to confront, dismantle, and reform the structural barriers that prevent children and youth from accessing safety, permanency, and well-being. We pull multiple levers to drive that change:

By elevating the stories of children and families, the work of our members, relevant data from our sector, and recommendations for change, we educate stakeholders and drive changes in legislation and funding that directly impact children, families, and providers of services. We continually bring together our members and the Administration to improve implementation of policies and practices that impact the sector.

# MEMBER BENEFIT Member Task Forces

CLM's task forces and coalitions are member-led and outcome-focused groups that lead the charge on developing sound policies, determining funding recommendations, collecting and reporting information, and sharing and identifying best practices and trends on specific children services across Massachusetts.

These groups provide CLM members the opportunity to leverage their knowledge, professional expertise, and insights into actionable policy, regulatory, and budgetary advocacy. State agency staff often attend meetings to join solution-focused discussions.

#### **Adoption Task Force**

Focuses on strategies to address permanency through adoption for youth in the DCF system, as well as long-term sustainability for families through professional and natural support networks and life-long connections.

#### **Family Preservation Coalition**

Advocates for the improvement in the continuum of services available to families in need. This includes strengthening supports to stabilize families and keep children safe and at home.

#### **Intensive Foster Care Task Force**

Advocates for increased capacity of the foster care system, especially comprehensive foster care within the continuum of care, including to provide expert support to foster families. Our members advance innovation and best practices and advocate for investment in sustainable services.

#### Family Resource Center (FRC) Task Force

Shares and enhances best practices among FRCs, educates and coordinates with key stakeholders about FRC services, and advocates for necessary policy changes and funding for FRCs and related family services and programs.

#### **Transition Age Youth Coalition**

Mobilizes experts in youth advocacy, homelessness, and foster care, as well as youth themselves, to improve supports and services for youth aging out of state care without permanency.

#### \*NEW!\* Peer Group for New CEO's and ED's

Connects new executive leaders within our membership to collaborate on shared issues.


CLM Provides **opportunities to amplify your organizational outreach** through our growing communications network to highlight your organization's jobs, events, trainings, and news to a wider audience.




