Family Information: married to Conner, 4 kids, Ruby Jane (13), Ellie Cate (11), Winston (9), Tillie (7)


Place of Employment or Occupation: Self-Employed Licensed Professional Counselor in Private Practice at Canterbury Counseling Center.
