**BALLOT LANGUAGE FOR
2018 PROPOSED CONSTITUTIONAL AMENDMENTS**

Proposed Amendment No. 1

Do you support an amendment to prohibit a convicted felon from seeking or holding public office or appointment within five (5) years of completion of his sentence unless he is pardoned?

Proposed Amendment No. 2

Do you support an amendment to require a unanimous jury verdict in all noncapital felony cases for offenses that are committed on or after January 1, 2019?

Proposed Amendment No. 3

Do you support an amendment to permit, pursuant to written agreement, the donation of the use of public equipment and personnel by a political subdivision upon request to another political subdivision for an activity or function which the requesting political subdivision is authorized to exercise?

Proposed Amendment No. 4

Do you support an amendment to remove authority to appropriate or dedicate monies in the Transportation Trust Fund to state police for traffic control purposes?

Proposed Amendment No. 5

Recent amendments to the constitution allow the freezing of property tax assessments for property owned by disabled veterans and their spouses and persons over age 65 (if their adjusted gross income meets certain guidelines), and 100 percent property tax exemptions for the surviving spouses of active duty military, first responders, law enforcement and fire protection officers killed while performing their duties. Do you support an amendment that would extend these special property tax benefits?

Proposed Amendment No. 6

The present constitution requires property subject to ad valorem taxes to be listed on the assessment roles as its assessed value, which is percentage of its fair market value, and it requires reappraisal at least every four years. A vote for would require phasing in over-four years, the increase in the assessed value of the residential property value increased by more than 50 percent. A vote against would require all residential property owners to pay the full increase in the assessed value of their property in the first year.
