## Birch Bay Chamber of Commerce (BBCC)

- BBCC & partners do not provide electricity, water or individual garbage collection. Dumpsters will be available for vendor use, and vendors are responsible for dumping their own garbage.
- BBCC does not provide tents, tables or chairs for vendors.
- Porta-potties will be available.
- BBCC will provide professional, licensed, on-site security overnight (when applicable).

## Vendors

- **Applications are only considered with complete documents and payment of fees.**
- We prefer no duplications. Applications are considered on a **first-come-first served basis**.
- Fees are non-refundable under any circumstances, including natural events.
- You are required to secure your booth, tent, equipment etc., in a way that any weather occurrence will not affect the public, other vendors, attendees or workers. **Stakes are strictly prohibited at Birch Bay Beach Park.** Sandbags or other weighted objects are acceptable and encouraged.
- This is a two-day event, and you agree to be set up and ready for business at the published start time of the event and will remain on-site and open for business **during the entire event**.
- You are responsible for removing all trash and maintaining a clean area throughout the event.
- Vendor locations will be assigned by the Event Coordinator. **Specific requests must be made during the application process.**

## Required Documents:

- 1) Certificate of Insurance (COI) – Certificate must reflect the below minimum insurance requirements:
  - Commercial General Liability Aggregate: \$2,000,000
  - Commercial General Liability CSL per occurrence: \$1,000,000
  - Product Liability CSL per occurrence: \$1,000,000
  - Property Damage CSL per occurrence: \$300,000
  - Business Automobile Liability CLS per occurrence: \$500,000
- 2) Additional Insured Endorsements - must name both the Birch Bay Chamber of Commerce and Whatcom County Parks & Recreation as Additional Insured, using the following language:
  - *Whatcom County, its departments, elected and appointed officials, employees, agents, and volunteers are included as an additional insured; Whatcom County Parks & Recreation Department, 3373 Mt. Baker Highway Bellingham, WA 98226.*
  - *Birch Bay Chamber of Commerce, it's departments, elected and appointed officials, employees, agents and volunteers are named as an additional insured; Birch Bay Chamber of Commerce, 4819 Alderson Rd. #103, Blaine, WA 98230.*
- 3) Endorsement for Primary and Noncontributory
- 4) Endorsement for Waiver of Transfer of Rights

**Please note:** Vendors are responsible for ensuring they meet all insurance requirements. **The Birch Bay Chamber of Commerce (BBCC) is not responsible for determining or providing guidance on the insurance specifications required by Whatcom County Parks and Recreation.** Failure to meet the above outlined insurance requirements will result in disqualification from participation in the event, as determined by Whatcom County.
