## HR SEMINAR – COMPLIANCE OF THE FEDERAL MOTOR CARRIER REGULATIONS AND REASONABLE SUSPICION – DRUG AND ALCOHOL RECOGNITION TRAINING.

He will be discussing USDOT requirements and how to meet **compliance for a Safety Audit or Compliance Review**. Driver qualifications, controlled substance/alcohol testing, log book/time cards, insurance, and vehicle maintenance requirements will be discussed.

Chad Rogers is a 20 plus year veteran of the trucking industry. He will be presenting on **Reasonable Suspicion – Drug and Alcohol Recognition**. The 49 CFR 382.603 in the FMCSA guidebook tells us that each supervisor of CDL drivers have to be trained in drug and alcohol recognition. Upon completion of this class, you will receive a certificate of training for Reasonable Suspicion of Drug and Alcohol Recognition.
