Dear Governor Reeves:

The Mississippi Academy of Family Physicians, representing 1,333 family physicians, residents and medical students across the state of Mississippi, would like to express our support of your leadership in this time of crisis. Our family physicians are transitioning to telephone, Telehealth, and drive-thru services to try and help care for those who do not need to be in the emergency rooms and hospitals. We appreciate your executive orders and the regulations lifted by various state agencies to allow these freedoms to occur. We greatly appreciate the leadership and expertise of Dr. Thomas Dobbs and the Mississippi Department of Health during this pandemic. As with general medical practice and medical practice during a time of crisis, family physicians remain the constant source of providing frontline medical care to the citizens of Mississippi.

The MAFP respectfully requests that you consider using the authority of your office in four specific ways, which would greatly help our efforts:

**(1) First, we implore you to help all family physicians in communities across the state obtain adequate personal protective equipment (PPE), so that we can continue to triage less-ill patients, without becoming infected ourselves.** The MAFP is hearing a desperate need for PPE from our members who maintain independent practices, many in rural areas. These doctors are small business owners who do not have a hospital system providing them with protective equipment, and they are failing to find resources to support them. Some healthcare providers are using makeshift PPE if proper PPE is not available. This is of great risk to doctors, staff, and patients. If our vulnerable rural areas lose healthcare providers to COVID-19, there is no one to care for communities during these weeks of isolation. The bottom line is that primary care is the backbone of all healthcare in Mississippi, and our state cannot afford to have communities without access to a physician due to exposure from lack of PPE.

**(2) Second, as we continue to see the impact of the first wave of infection throughout the state, please consider mandated “Safer at Home” orders much like our neighboring state of Tennessee just executed.** Even if a violation of these orders was punished only by a ticket, the overwhelming majority of Mississippi citizens would respect your orders – and we, as a state, could expect fewer infections and fewer deaths;

**(3) Third, we also request a mandatory self-quarantine of 14 days for all individuals returning from international and domestic travel, as well as a mandatory 14-day quarantine for individuals from other states seeking refuge in Mississippi; and**

**(4) Fourth, consider closing for at least two weeks all non-essential businesses for public use, limiting essential activity and essential services to the greatest extent possible while using thoughtful planning, careful consideration, and strict adherence to CDC guidelines and safety recommendations.**

You have a unique opportunity to solidify your legacy as a champion for public health by ensuring the health and safety of the public during this pandemic. Without a strong, definitive statement from your office, the state will remain a patchwork of different rules and guidelines with boundaries that are arbitrary and a virus that does not respect them. COVID-19 is a public health enemy and Mississippi leaders and citizens should act accordingly. We need an effective strategy to combat the COVID-19 pandemic now.

We are all tasked with making sacrifices and hard decisions for the well-being of many. The Mississippi Academy of Family Physicians strongly urges you to act immediately to protect all Mississippians so that our workforce and economy can rebound swiftly and our citizens can resume lives of safety and normality. We understand the difficult position you are in. These are unprecedented times which call for unprecedented action.
