JOB PURPOSE: The Epidemiologist, as a short-term, technical consultant/contractor, will support the planning, coordination and implementation of the Republic of the Marshall Islands' (RMI) Ministry of Health and Human Services (MOHHS) COVID-19 Preparedness and Response Plan, with specific focus on strengthening systems, policies, protocols and capacities for effective and timely detection and surveillance of COVID-19 transmission across the RMI.

KEY RESPONSIBILITIES: Under the direction and supervision of the designated RMI MOHHS Supervisor, the Epidemiologist will:

1. Work collaboratively with RMI MOHHS epidemiology and surveillance staff to review and verify data collected from hospital medical records, lab information systems and other sources to inform routine maintenance, compilation and dissemination of timely and accurate weekly National COVID-19 Situation Reports (sitreps) and associated COVID-19 response dashboards to key RMI MOHHS leadership, staff, local stakeholders and partners;
2. Support designated RMI MOHHS Supervisor and local clinical teams to review suspected COVID-19 Persons Under Investigation (PUIs) per CDC and WHO-recommended criteria for surveillance reporting and case investigation, including technical support for the refinement of field-based contact tracing standard operating procedures (SOPs), protocols and data recording/reporting templates for public health surveillance and reporting purposes, including supporting contract tracer training efforts, as needed;
3. Perform epidemiological and statistical analyses on data with interpretation for program and policy development, and propose corrective actions or public health responses/interventions to prevent or alleviate COVID-19 transmission risk based on epidemiological findings;
4. When required, support contact tracing and other epidemiological/case investigation efforts in the field/community and at active COVID-19 quarantine sites;
5. Assist the RMI MOHHS' Senior Leadership Team (SLT) to develop and further refine evidence and science-based national health policies for comprehensive, quality and timely surveillance, including context-appropriate COVID-19 testing strategies for clinical and public health purposes;

6. Support coordination of COVID-19 surveillance and national reporting efforts with key partners including the US CDC, WHO (IHR and PSSN) and SPC PPHSN, and when required;
7. Support RMI MOHHS and its local and regional partner efforts to conduct post-COVID-19 evaluations/after-action reviews (AARs) and other similar post-response assessment activities to inform on-going epidemiology and surveillance program improvement efforts;
8. Support on-going capacity development, training and coaching/mentorship of local RMI MOHHS epidemiology and surveillance counterparts and relevant program staff, including assisting and/or serving as adjunct faculty for the Pacific regional roll-out of the Strengthening Health Interventions in the Pacific (SHIP) field epidemiology training program (FETP) jointly implemented by SPC, WHO, PIHOA and US CDC accredited by Fiji National University;
9. Attend regularly scheduled conference calls with grantors (CDC) and other related epidemiology and infection program conference calls and meetings;
10. If and when assigned, be an active team member to the RMI MOHHS' COVID-19 Response Task Force and National Emergency Operations Center, including assisting with any public information dissemination efforts when required; and
11. Perform other duties as assigned by the RMI MOHHS Secretary of Health and designated RMI MOHHS Supervisor appropriate to the general terms of this position.

Key Deliverables:

1. Contribute to quality and accurate weekly National COVID-19 Situation Reports (SitReps) and associated COVID-19 response dashboards issued to key RMI government stakeholders and relevant partner reporting mechanisms;
2. Updated RMI MOHHS epidemiological investigation and public health surveillance SOPs and protocols for COVID-19;
3. Key RMI MOHHS and government stakeholders and partners are kept informed of critical COVID-19 epidemiological information and public health risk to support effective and timely responses; and

JOB PURPOSE: The Epidemiologist, as a short-term technical consultant/contractor, will support the planning, coordination, and implementation of the Republic of the Marshall Islands' (RMI) Ministry of Health and Human Services (MOHHS) COVID-19 Preparedness and Response Plan, with a specific focus on strengthening systems, policies, protocols, and capacities for effective and timely detection and surveillance of COVID-19 transmission across the RMI.

KEY RESPONSIBILITIES: Under the direction and supervision of the designated RMI MOHHS Supervisor, the Epidemiologist will:

1. Review and verify data collected from local hospital medical records, lab information systems, and other sources to inform and contribute to the routine maintenance, compilation, and dissemination of timely and accurate weekly National COVID-19 Situation Reports (sitreps) and associated COVID-19 response dashboards to key RMI MOHHS leadership, staff, local stakeholders and partners. The National COVID-19 Situation Report is collated and distributed by the RMI MOHHS Epidemiology and Surveillance team based in Majuro. This position will be responsible for collecting, collating, and transferring COVID-19 and related epidemiological information from the Kwajalein Atoll Health Care Services to the RMI MOHHS Epidemiology and Surveillance team lead in Majuro;
2. Support designated RMI MOHHS Supervisor and local clinical teams to review suspected COVID-19 Persons Under Investigation (PUIs) per CDC and WHO-recommended criteria for surveillance reporting and case investigation, including technical support for the refinement of field-based contact tracing standard operating procedures (SOPs), protocols, and data recording/reporting templates for public health surveillance and reporting purposes, including supporting contract tracer training efforts, as needed;
